### Loveland Habitat for Humanity Celebrates 25 Years

It's been 25 years since the first homeowner with Loveland Habitat for Humanity moved into their home. Since then, the affiliate, which serves families in Loveland, has built in excess of 100 homes and changed countless lives in the process.

Loveland Habitat recently celebrated the kick off of its 25<sup>th</sup> Anniversary milestone with a 5-event celebration in Willow Park, its newest subdivision. On Saturday, February 18, a ribbon cutting, a home dedication, a ground breaking, a Thrivent brunch and the 25<sup>th</sup> Kick Off took place with more than 100 in attendance.

The day started with an official Loveland Chamber of Commerce Ribbon Cutting, opening the door to the next 25 years of service in Loveland. Habitat's newest homeowner,

Tracy, then celebrated her home's dedication with community members, her family and lots of friends. Hers is the first home completed in Willow Park, which is on 27<sup>th</sup> Street just south of the Loveland Post Office. Thirteen homes are planned for the neighborhood.

"I never thought I'd be a homeowner. I thought there was no way I could do it on my own," she said during her dedication. "I really feel for the first time I have a community and a neighborhood with good friends. We all know each other because we are all working on each other's home."

Gwen Stephenson, Executive Director for Loveland Habitat, says this is what makes the habitat model unique, "That's what's exciting about Habitat: You just don't build homes, you build humanity," she said.

The affiliate's 25<sup>th</sup> Anniversary Kick Off was celebrated right after Tracy's dedication and took place in the 100<sup>th</sup> home currently under construction. Guest speakers, including Pastor Edward Smith – one of Loveland Habitat's original founders – and Veronica – one of the original home owners who just paid off her mortgage – shared their insights with the crowd. Loveland Mayor Cecil Gutierrez was present and accepted a plaque from Stephenson, commemorating the strong partnership between Loveland Habitat and the City of Loveland.

The day also saw the groundbreaking for Luis, Ruth and their 5 children. The family is the recipient of the Thrivent home, which is funded through a partnership among Thrivent Financial, Habitat for Humanity International and Loveland Habitat for Humanity. Loveland Habitat has been participating in the program for six years to construct one home a year, paying only 35 percent of the costs. Like any other Loveland Habitat Family, Luis and Ruth had to qualify for the home – criteria includes good credit, a need for housing, Loveland residency, income guidelines and a willingness to partner through 250 sweat equity hours per adult in the household. When complete, their home will be Loveland Habitat's 105<sup>th</sup>. The groundbreaking was followed by a special Thrivent luncheon attended by Luis and Ruth, along with other members of the Lutheran Community.

Loveland Habitat for Humanity built eight homes in 2011 and expects to build 12 by the end of this year. Half a decade ago, the average was four to five homes a year. "It's a huge accomplishment. We're celebrating our affiliate and our community," Stephenson said. "A number of affiliates have suffered through this recession. Our organization has built capacity. We are so very grateful for the support of our community."

## **NATIONAL BREAST CANCER FOUNDATION AWARDS FUNDS TO MCKEE CANCER CENTER**

### **Center Will Expand Services Offered in Northern Colorado**

The National Breast Cancer Foundation has recently awarded McKee Medical Center's Cancer Center with a \$25,200 grant. The grant is part of the National Breast Cancer Foundation's National Mammography Program, and will provide mammograms and ultrasounds for the medically underserved in Northern Colorado.

The mission of the National Breast Cancer Foundation is to save lives through early detection and to provide mammograms for those in need.

According to Kristen Freund, an Oncology Social Worker at McKee's

Cancer Center, "The grant from the National Breast Cancer Foundation will be instrumental in serving uninsured and underinsured women and men in Northern Colorado with breast cancer screenings that would otherwise be unattainable. With budget cuts occurring at the state and federal level, the need for free breast cancer screenings will continue to grow."

McKee's Cancer Center provides integrated cancer treatment programs, clinical trial participation and education and prevention programs. Freund states, "At McKee we are able to provide women and men with the full continuum of care for breast cancer. If a person is diagnosed with breast cancer we also have funds from Susan G. Komen to offer treatment services at our Cancer Center. It is wonderful to be able to offer this service in Northern Colorado and help ease the financial burden that prevents many in our community from life-saving breast cancer screenings and treatment."
