Partnerships in Action

Did you know that there are youth in your own community who are struggling? These youth want and need positive adults in their lives acting as mentors to help them navigate the challenges they face and grow into healthy adults.

For 30+ years Partners Mentoring Youth has been committed to providing one to one mentoring relationships for these youth, and we have seen hundreds benefit from those relationships. Mentors have an immediate and long lasting positive impact for kids!

Unfortunately, the waiting list for kids to get matched with mentors is extensive. The number of youth referred to our program far exceeds the number of volunteers stepping up to mentor. In the Loveland/Berthoud area alone, we currently have 36 youth, 24 boys and 12 girls, on our waitlist to be matched with mentors. This equates to 12 – 18 months wait time for boys and approximately 6 months for girls. We are currently unable to accept new youth referrals due to this situation.

Loveland Habitat for Humanity and the Butterfly Effect...

What is the butterfly effect? It is a term used to describe how small changes to a condition or situation may affect large, complex systems. This concept comes from findings that the flapping of a butterfly's wings in South America could affect the weather in Texas, meaning that the tiniest influence on one part of a system can have a huge impact on another part. Habitat for Humanity is an organization that reflects this theory, attributed to mathematician Edward Norton Lorenz. Having built 500,000 affordable homes for 2.5 million people worldwide, this Christian ecumenical organization has the brave vision that all seven billion people on earth will have a decent place to live. But how does this happen? How does one organization take on such a monumental task?

Enter the butterfly effect . . . of each person who does something in the name of Habitat. When people donate to our Loveland Habitat ReStore or give cash to help build homes in our community, they also help build homes in another part of the world. When volunteers lift hammers or paint brushes to help build or improve homes in Loveland, they stand side by side thousands of volunteers across the world to diminish homelessness and poverty housing. When Habitat homeowners walk across the threshold of their new homes, futures are immediately transformed. These houses are not just four walls, but places of haven for their families, neighbors and friends.

Founder, Millard Fuller, said, "Habitat for Humanity welcomes all people to build with us in partnership. The Bible teaches that God is the God of the whole crowd. God's love leaves nobody out, and my love should not either." This understanding inspires people from all around the world to steadily do their small part to build more houses in more countries- and thereby conquer one of the largest social problems of our time and the future.

Loveland Habitat for Humanity is celebrating its 25th Anniversary this year, helping to make Loveland families stable, sustainable and successful since 1987, and contributing to the Butterfly Effect. We also recently just dedicated its 100th Home. Matthew, an Iraqi War Veteran, his wife Rachel, and their family are very grateful for all the volunteers who picked up a hammer to make their dream of homeownership come true.

As we celebrate 25 years, now and into our upcoming September 11-15 Build-A-Thon, we extend a sincere and warm "Thank you," to all those who have contributed to the success of our families , our affiliate and the promise of another 25 years of service in Loveland. You are all our Butterflies.


Colorado State Division of Housing has provided additional funding to the Larimer Home Ownership Program (LHOP), to continue its down payment assistance program. The program provides a 2% interest rate loan for up to \$10,000 for first time home buyers purchasing in Larimer County, including the cities of Loveland, Berthoud, Estes Park and Wellington.

The Larimer County Extension Office announces the 2012 Food Preservation Workshop series.

If you are going to preserve your own foods this summer it is important to use up-to-date food preservation methods and processing times. Beginning in April, Larimer County Extension's workshops will include methods of canning, pickling and dehydrating using safe, research-tested methods to avoid foodborne illness.

Springtime is the ideal time to begin planning how you will preserve the fruits and vegetables that will be abundant in the coming months. Even if you don't have time or land to grow your own food, you can take advantage of a wide variety of high quality produce at local farmers' markets and roadside stands.

If you are new to preserving foods or if you haven't done it for a while, be sure to check the workshop schedule. Preserving your own food lets you enjoy delicious, locally grown fruits and vegetables throughout the year.
