


Introduction

The Loveland Parks and Recreation Foundation was established in 1983, as a non-profit organizations to foster and encourage the advancement of parks and recreation opportunities in Loveland. A nine-member board of citizens governs the Foundation and manages the activities of the organization. Fundraising is the Foundation's primary function. The Foundation provides a means for concerned and interested citizens to make donations in support of the services, programs and facilities of the Loveland Parks and Recreation Department.



Loveland Tee Off for Kids Golf Tournament and Arts & Crafts Festival served as fundraising opportunities in 2010. The Foundation focused its spending on the youth recreational scholarship program, managing donations, accepting and applying for grants on behalf of the Parks and Recreation Department, and purchasing additional recreational equipment. The Foundation once again served as a mechanism to expand taxpayer dollars and serve the recreational needs of the community.

Youth Recreational Scholarship Program

As part of the Foundation's commitment to the youth of the community, the Youth Scholarship program was continued in 2010. The Program provided recreational opportunities to children and families who may not have otherwise been able to participate in programs due to financial limitations. In its twentieth year, the scholarship aided 275 children (132 families) in 22 program areas, totalling \$15,240 in resources to families. Referrals were received from schools, social service agencies, and recreation coordinators. The scholarship program is a unique local resource for assisting youth in recreation program participation.

Donations

During 2010, the Foundation administered \$16,600 in varying donations, affecting both facilities and programming. Examples of donations include: trees, benches, flowers, athletic equipment, park equipment, the fishing derby and adaptive recreation programs. Because the Foundation is a non-profit 501-3(c) organization, it serves as a mechanism for receiving donations on behalf of the Parks and Recreation Department.

Parks and Recreation Equipment/Amenities

Since the Foundation experienced a successful fundraising year in 2010 it was able to purchase amenities at the new Fairgrounds Park and provide additional recreational scholarship funding to families experiencing financial challenges.
