The City of Loveland Art in Public Places program invites students (K-12th grade) that are eager to be part of a unique community art project! In this hands-on workshop, students will work closely with the *Equinox* Design Team, the artists who won the sculpture competition for the intersection of I-25 and Highway 34! You will learn from the best while creating your own artwork.

#### Students will be instructed on:

Artists' processes in creating public art
Finding inspiration for your own artwork
How to design elements that express your artistic vision
How to create art that is safe for public display

#### The workshops will be held as follows:

K-5th graders Monday, February 17 10am — 12pm 6th-8th graders Monday, February 17 1:30pm—4:30pm 9th-12th graders Wednesday, February 19 2pm—5pm

While this workshop is free, students must apply for this program. Only 15 students will be selected for each age group. Students will use a variety of 2D media to assist the *Equinox* artists in developing images that represent their hometown.
