-Other commission member updates: Lauren- topic: private attorney; voting was cancelled that night because people were upset about the circumstances; majority of public against hiring the private attorney...\$400,000 annually; also considering hiring a lobbyist for the school board; there was a letter signed by previous board members and presidents...presenting concern

b. Jenni- no report

c. Phil- 5 story parking garage with retail all around between Lincoln and Cleveland; New council building near the catalyst; finances: around \$15 mill collected above what we've spent this year; 29th and Wilson-fire station ground breaking next week; approved \$25,000 for another Octoberfest; approved a new park by Centerra and will be adjacent to the new school that will be built; survey-next year it needs to be modified so that more people are included- we are at a 98% confidence level....but there wasn't a large mix

IV. ACTION ITEM FOLLOW UP

- a. CanDo Project Status: focus- transportation, pedestrian safety. New app CanDo acquired- designed to send out to a whole populous and place pins on a map(SMAP). Areas that are poorly managed/constructed...want us to start so that our city gets involved. Also can include positive points...mainly showing what the population thinks about certain areas. Maple Terrace- new sidewalk is being built; Next meeting January 23, 5-7
- b. Block Schedule: seriously considering the TVHS variation

- a. Guest Speaker: Judge William Starks, City of Loveland Municipal Judge
Possibilities of a teen court. case referred to a teen court...and the jurors come up with a solution. Would meet once or twice a month during the school year. participation comes also from jury and attorneys. Wouldn't go to teen court unless they plead guilty- teen court would decide how they will be sentenced. Sentence depends on attendance records at school and other factors. Attorneys have very strict confidentiality agreements. In some cities-only first time offenders. Not about legal representation- more about justice. Peers tend to be harder on each other than adults to kids. Teens can develop a legal career off of this. Teen court would not be open to the public.
