Request for 60-day extension on Surrender Application Submittal

Dear Secretary Bose:

This letter serves as a request for the City of Loveland to be granted a 60-day extension on the Surrender Application. Enclosed is a copy of the FERC letter dated June 27, 2014 regarding the City's original intention to file the surrender application by September 11, 2014. If granted the request, the City would file its Surrender Application by November 11, 2014. The reasons for this request include:

- The City developed a draft site plan for restoration of lands affected by the project, including components on USFS lands. USFS provided comments on August 28, 2014. The city needs additional time to discuss site restoration on USFS lands, based on comments received. These discussions could affect the outcome of the restoration, cost of the restoration, and the terms of the license surrender.
- The license surrender application and environmental report cannot be completed until a final site plan is developed.
- The City needs additional time for consultation with federal, state, and local agencies, including SHPO and USFWS.
