The government adds fluoride to drinking water supplies insisting that it is safe, beneficial and necessary, however, scientific evidence shows that fluoride is not safe to ingest and areas that fluoridate their drinking water supplies have higher rates of cavities, cancer, dental fluorosis, osteoporosis and other health problems. Because of the push from the aluminum industry, pharmaceutical companies and weapons manufacturers, fluoride continues to be added to water supplies all over North America. There is a growing resistance against adding toxic fluoride to our water supplies, but unfortunately, because fluoride has become "the lifeblood of the modern industrial economy, there is too much money at stake for those who endorse water fluoridation. The 'dental care prevention myth' associated with fluoride, originated in the United States in 1939, when a scientist named Gerald J. Cox, employed by ALCOA, the largest producer of toxic fluoride waste and at the time being threatened by fluoride damage claims, fluoridated some lab rats, concluded that fluoride reduced cavities and claimed that it should be added to the nation's water supplies. In 1947, Oscar R. Ewing, a long time ALCOA lawyer, was appointed head of the Federal Security Agency, a position that placed him in charge of the Public Health Service(PHS). Over the next three years, eighty-seven new American cities began fluoridating their water, including the control city in a water fluoridation study in Michigan, thus eliminating the most scientifically objective test of safety and benefit before it was ever completed.

American 'education and research' was funded by the Aluminum Manufacturing, Fertilizer and Weapons Industry looking for an outlet for the increasingly mounting fluoride industrial waste while attaining positive profit increase. Fluoride, a waste constituent in the manufacturing processes of explosives, fertilizers and other 'necessities', was expensive to dispose of properly and until a 'use' was found for it in America's water supplies, the substance was only considered a toxic, hazardous waste. Through sly public re-education, fluoride, once a waste product, became the active ingredient in fluorinated pesticides, fungicides, rodenticides, anesthetics, tranquilizers, fluorinated pharmaceuticals, and a number of industrial and domestic products, fluorinated dental gels, rinses and toothpastes. Fluoride plays a tremendous part in multibillion-dollar industrial and pharmaceutical income.

But does fluoride actually prevent tooth decay? Not according to the largest study ever conducted on fluoridation and oral health. 39,000 school children in 84 areas around the U.S. were studied in the mid-80's, and the results showed no statistical difference in tooth decay rates between fluoridated and non-fluoridated cities.

Meanwhile, tooth decay trends tracked by the World Health Organization from 1970 to the present show that the incidence of decayed, missing or filled teeth has been steadily in decline with each passing year in the U.S., France, Germany, Japan, Italy, Sweden, Finland, Denmark, Norway, The Netherlands, Northern Ireland, Austria, Belgium, Portugal, Iceland and Greece. And why are the numbers of decayed teeth on the decline?

Better oral hygiene and improved dental practice is the most obvious **answer**. It's **certainly not the fluoride**. Because of all of those countries, only one adds fluoride to the public water supply: the United States.

A few of the countries listed above used to put fluoride in some of their water, but they eventually wised up to the dangers of this aluminum by-product. And here's some truly radical thinking for you: many of those countries simply refuse to run fluoride through every citizen's faucets based on the idea that health treatments should be a personal choice and not mandated by the government. What a concept!

Bottom line read what is quoted on your fluoridated tube of toothpaste: If swallowed call the Poison Control Center! How many children do you think has ever swallowed toothpaste? Simply stated children and adults are being poisoned. If studies are showing that there is absolutely no benefit to dental health why are we still using it in America's water supply?
