The meeting was called to order by Pat Kistler. A motion was made and seconded respectively by Bev Cardarelli and Mark Kirkpatrick to approve the minutes from April 6. Motion carried. All approved.

CHIEF'S UPDATE

- Chief gave a review of Bill Cahill's memo about how the elimination of the proposed food tax would affect the Loveland Police Department. There would be an immediate \$250,000 in budget reductions followed by an additional 1%, which could be as high as \$190,000. Chief said he will consider the preservation of life and property as being a critical part in making his decisions. Board members discussed how the removal of food tax would affect the Department. The Board decided to submit a letter to City Council expressing their concern over the budget reductions and "stop doing" list. A motion was made and seconded respectively by Erin Frisch and Mark Kirkpatrick that board member John Tindall write the letter. Motion carried.
