1. On January 8, 2014 the U.S.Court of Appeals for the Tenth Circuit issued its opinion on an appeal taken by Myers and remanded the case to this Court for further proceedings, [Appellate case 12-1482, Document 01019182847].

2. The Mandate was issued herein on January 29, 2014.
