Temporary Construction Trailer Submittal/Conex Requirements

Requirements for Conex used for storage (Storage only for materials, not to be used as office.)

- Must submit trailer/Conex drawing with dimensions, on a plot plan.
- No tie downs required if sitting directly on level ground
- Permit required for electrical/plumbing/ mechanical work
- Temporary structures and uses shall conform to the structural strength, fire safety, means of egress, accessibility, light, ventilation, and sanitary requirements of this code as necessary to ensure public health, safety, and general welfare.
- Temporary structures that cover an area greater than 120 square feet (11.16 m²), including connecting areas or spaces with a common means of egress or entrance that are used or intended to be used for the gathering together of 10 or more persons, shall not be erected, operated or maintained for any purpose without obtaining a permit from the building official.
- The construction documents shall include a site plan indicating the location of the temporary structure and information delineating the means of egress and the occupancy load.

Temporary structures shall be located according to the requirements of Table 705.5, based on the fire-resistance rating of the exterior walls for the proposed type of construction.

If all requirements are not met, A letter indemnifying the city from all responsibility will be required at submission.

Requirements for trailers/Conex used for Office/Sales

- Tie downs are required for this application
- Permit required for electrical/plumbing/mechanical work
- Temporary structures and uses shall conform to the structural strength, fire safety, means of egress, accessibility, light, ventilation, and sanitary requirements of this code as necessary to ensure public health, safety, and general welfare.
