EXECUTIVE SUMMARY

The Consolidated Annual Performance Evaluation Report (CAPER) details how the City of Loveland, Colorado expended Community Development Block Grant (CDBG) funds from October 1, 2014 through September 30, 2015, hereafter referred to as the 2014-2015 grant year, or the 2014-2015 program year.

The City of Loveland received \$301,648 in CDBG funding for the 2014-2015 grant year, and spent an additional \$270 from a prior year allocation and \$74,970 in funding that had previously been returned to HUD for a total distribution of **\$376,888**. By the end of the program year \$13,803.29 (3.7%) remained unspent; all of the unspent funding was in the bricks and mortar category.

Seven thousand fifty-five (7,055) people were served with CDBG funds during the program year and 44 units of housing were rehabilitated. Seventy-one percent (71%) of funds spent during the grant year were used for two public facilities, land purchase to build affordable housing, rehabilitation of existing affordable housing, and grants for emergency home repairs. Twelve percent (12%) of spent funds provided public services to victims of domestic violence and persons living with HIV or AIDS. Seventeen percent (17%) of funds paid for administration of the CDBG program. When the unspent funding in the bricks and mortar category is spent, the percentages will be 72%, 12% and 16% respectively.

The CAPER provides details required by the U.S. Department of Housing and Urban Development showing how activities funded with CDBG met goals established in the 2010-2015 Consolidated Plan, followed by detailed spending during the fifth grant year, including how persons with low income and special needs were served, how housing needs were addressed, and how the public was made aware of the City's use of funds.

RESUMEN EJECUTIVO

El Reporte Consolidado de Rendimiento y Evaluación Anual (CAPER, por sus iniciales en inglés) explica cómo la Ciudad de Loveland, Colorado gastó los fondos del Ramo de Desarrollo Comunal (CDGB, por sus iniciales en inglés) desde octubre1, 2014 hasta septiembre 30, 2015, el cual se va a mencionar como el año 2014-2015 de la subvención, o el año 2014-2015 del programa.

La Ciudad de Loveland recibió \$301,648 en fondos de CDBG para el año 2014-2015 de la subvención, y gastó \$270 de una distribución de un año anterior y \$74,970 en fondos que habían sido devueltos a HUD para obtener un total de **\$376,888**. Al final del año del programa, \$13,803.29 (3.7%) no se habían gastado; todos los fondos sin gastar eran de la categoría de bienes raíces.

Siete mil cincuenta y cinco (7,055) personas recibieron servicios con fondos de CDBG durante el año del programa y se rehabilitaron 44 unidades de vivienda. Setenta y un por ciento (71%) de los fondos que se gastaron durante el año de la subvención se usaron para dos instalaciones públicas, compra de terreno para construir vivienda asequible, rehabilitación de vivienda asequible que ya existía, y subvenciones para arreglos de emergencia del hogar. Doce por ciento (12%) de los fondos que se gastaron le proveyeron servicios públicos a víctimas de violencia doméstica y a personas que viven con el VIH o el SIDA. Diecisiete por ciento (17%) de los fondos pagaron la administración del programa CDBG. Cuando se hayan gastado los fondos por gastar en la categoría de bienes raíces, los porcentajes van a ser 72%, 12% y 16% respectivamente.

El CAPER provee los detalles que el Departamento de Vivienda y Desarrollo Urbano de los EE.UU. requieren para mostrar cómo las actividades que recibieron fondos de CDBG cumplieron con las metas establecidas en el Plan Consolidado de 2010-2015, seguido por detalles de los gastos durante el quinto año de la subvención, incluyendo de qué manera se les proveyó servicios a las personas de bajos recursos y de necesidades especiales, cómo se encargaron de las necesidades de vivienda, y de qué manera se le informó al público acerca del uso de los fondos por parte de la Ciudad.

MEETING NATIONAL OBJECTIVES

All activities funded during the 2014-2015 program year fell under the Low/Mod (LMI) objective, specifically, Low/Mod Limited Clientele (LMC) and Low/Mod Housing (LMH) activities. The National Objective used for each activity can be found on the table on page 4.

CHANGES IN FUNDING DISTRIBUTION

The 2014-2015 allocation for the City of Loveland was \$301,648. An additional \$75,240 was distributed during the program year.

The City of Loveland returned \$74,970 to HUD in November 2013. The funding was originally allocated to the Loveland Housing Authority and was used for water rights for market rate homes, which was an ineligible expense. The funding was reallocated to the House of Neighborly Service for the Community Life Center public facility.

PUBLIC SERVICE ACTIVITIES (GOAL #3)

The City of Loveland contributes \$500,000 each year to area non-profits that provide public services to low and moderate income Loveland residents. Goal #3 (page 3), Decrease poverty in the community by financially supporting services and facilities that meet basic needs and provide self-sufficiency opportunities, is further described in the Consolidated Plan as "assisting low-income households through public service activities including child care, case management, mental health, health care, services to persons with disabilities and seniors." The following organizations received a portion of the distributed \$500,000 to address these five issues.

A list of all results produced by public service agencies funded by the City of Loveland during the 2014-2015 grant year, and benefitting Loveland residents, is as follows:

- 366 people received counseling and support to leave a violent relationship through Alternatives to Violence.
- 33 site-impaired residents received 8,736 hours of news and other broadcasts to keep them informed of local issues through Audio Information Network.
- 1,195 young people received services and attended events at the Boys & Girls Club.
- 294 adults increased reading comprehension; basic skills in math, writing, and computer literacy; and GED preparation assistance through the Center for Adult Learning. 10 students received their GED and 20 started attending college.
- 31 young people received a scholarship to attend diversion classes to avoid further involvement with the justice system.
- About 300 homeless and very low-income residents were served more than 36,000 meals through the Community Kitchen.
- 34 children were placed with a Court Appointed Special Advocate (CASA) after a dependency and neglect case was started through CASA.
- 237 children were able to spend quality time with non-custodial family members through the Harmony House, operated by CASA.
- 120 people received counseling and support to leave a violent relationship through Crossroads Safehouse.
- 2,969 people with disabilities worked with case managers to aid in independent living through Disabled Resource Services.
- 83 physically and/or mentally disabled residents were able to attend a support facility through Elderhaus, Respite Care, or WINGS/Easter Seals.
- 10,144 residents received food from the Food Bank for Larimer County, 3,352 residents received food from the House of Neighborly Service, and 1,815 young people received a free meal and snacks from Kids Café, a program of the Food Bank.
- 24 low-income Loveland residents received medical equipment or health care supplies at no cost through GoodHealthwill.
- 12 at-risk youth participated in a therapeutic riding program to assist with communication and self-confidence.
- 2,497 community members received financial assistance to help with a utility bill, prescription drugs, or other basic needs through the House of Neighborly Service.
- 102 abused youth completed at least one interview with a trained forensic interviewer through the Larimer County Child Advocacy Center.
- 65 homeless youth, or youth lacking family support, received support to apply for a job and learn life skills.
- 28 at-risk youth received time management, social skills and work experience through Loveland Youth Gardeners
- 4 adults suffering from memory impairment received care through the Stepping Stones program of the McKee Medical Center Foundation.
- 547 home-bound residents received a hot meal through Meals on Wheels.
- 519 families received housing counseling assistance through Neighbor to Neighbor.



- 33 Loveland residents living with HIV/AIDS received specialty case management and medical care through Northern Colorado AIDS project.
- 47 youth were matched with an adult mentor through Partners Mentoring Youth.
- 78 single parents received case management as they worked toward career and/or educational goals leading to self-sufficiency through Project Self-Sufficiency.
- 19 residents with acute health care issues received skilled care or were able to engage in self-care through Rehabilitation and Visiting Nurse Association.
- 295 seniors, unable to drive or take public transportation, received 9,899 rides through Senior Alternatives in Transportation.
- 169 low-income children were able to attend child care or preschool through Thompson Valley Preschool or Teaching Tree Early Childhood Learning Center.
- 326 low-income residents received mental health and substance abuse treatment through Touchstone Health Partners.
- 127 young people received substance abuse counseling through Turning Point.
- 322 low income seniors received a nutritious meal through Volunteers of America.

ASSESSMENT OF ANNUAL PROGRESS

The City of Loveland distributed grant funding during the 2014-2015 program year to further the three goals listed on page 3 with some success and resulted in meeting 100% of the five year planned outputs 56% of the time. Areas where the outputs did not produce the planned goal include the following:

- Neighbor to Neighbor continued to provide housing counseling in Loveland, although activities were not funded with CDBG and were not reported in IDIS.
- The number of lots purchased by Habitat for Humanity to build low income housing that was attributed to CDBG was reduced over the five year period in order to try to close the projects faster. Habitat purchased more than 25 lots but most were not purchased with CDBG and were not entered into IDIS.
- The down payment assistance program was not funded with CDBG during the last two years of the five-year Consolidated Plan, which means the total outputs did not increase after 2013. Again, only CDBG funded down payments are reported in the CAPER. The program has other funding sources but results from those sources are not available.
- No Loveland agencies are planning on building additional transitional housing in the
 near future. In 2014, one provider reported that the agency moved from a two-year
 transitional housing program to a nine-month program, which is a goal of the National
 Alliance to End Homelessness. Now, more than twice the number of families will be
 able to be served with transitional housing in Loveland.

Outputs that were successful include increasing (and rehabilitating) public facilities, housing rehabilitation, case management for low income Loveland residents, and overnight shelter for homeless families and individuals, including domestic violence victims.

For the next five-year Consolidated Plan, non-CDBG funded activities that are listed as goals of the plan will be entered into IDIS and reported in subsequent CAPERs.



PROGRAM NARRATIVE

AFFIRMATIVELY FURTHERING FAIR HOUSING

As described in the City of Loveland 2010-2015 Consolidated Plan, and as part of the City of Loveland's certification to affirmatively further fair housing, the City assumes the responsibility of fair housing by conducting an Analysis of Impediments to Fair Housing Choice (AI) and by taking appropriate actions to overcome the effects of any impediments identified in the analysis. The City of Loveland last updated the Analysis of Impediments to Fair Housing Choice in 2012.

The Community Partnership Office (CPO) worked with a consultant throughout 2015 to ensure compliance with Fair Housing, Title VI of the Civil Rights Act and the American with Disabilities Act regulations. Below are actions that were taken in 2015 under all three federal regulations.

<u>SUBRECIPIENT COMPLIANCE</u> – The CPO worked to ensure that recipients of City of Loveland CDBG funding are compliant by completing the following:

- The CPO conducted a survey of funded non-profits to get a better understanding of the
 ability of staff members to provide non-English speaking services. A copy of the survey
 and the results are available upon request. The CPO will use the information to ensure
 that appropriate translation services are occurring, including certifying staff members.
- The CPO held a Title VI/Fair Housing/ADA webinar for local non-profits. The webinar was mandatory for recipients of CDBG funding and strongly suggested for non-profits that are known to receive other federal funding. Of the 15 agencies required to attend, 10 were present at the first showing. A second webinar was held in November and was attended by the remaining five agencies. An additional 20 agencies that receive other federal funding participated in one of the two webinars.
 - O Under Fair Housing, the webinar included legal requirements, a discussion of housing discrimination and equal access regardless of sexual orientation or gender identity, creating a language access plan, reasonable accommodations, and the new Fair Housing Rule. Under Title VI and the ADA, the webinar included accessing certified/assessed interpreters or bilingual staff, translating vital documents, language assistance to residents of Limited English Proficiency, and using technology and other auxiliary aids for communication. From the webinar, the City of Loveland CPO and subrecipients of federal funding, are working on an Effective Communication Plan and a Limited English Proficiency Plan. In 2016, the CPO will start monitoring agency programs to help with deficiencies. Agencies have already submitted information about their ability to work with non-English speaking clients through the survey, and will now collect additional data to better understand the number of non-English clients requesting services.
 - The webinar will be held again from time to time as new subrecipients receive CDBG and as agencies known to have other federal funding apply for assistance with the City of Loveland.



- Monitoring will include: Limited English Proficiency plan, Effective Communication plan, certification process for bilingual staff members, and translation of vital documents.
- Additional "I Speak" cards were distributed to non-profits during both webinars and about 75 will be mailed in December.

COMMUNITY OUTREACH

- In 2014, the CPO received information about potential discrimination against homeless men who are HIV positive. While only one instance was substantiated, both shelter directors thought they could benefit from staff training, which was the desired outcome of the CPO.
- The CPO was also informed that a local non-profit that provides service to the homeless was asking staff members to pray and had engaged in alleged discrimination against guests based on sexual orientation. In April, the City of Fort Collins Office of Social Sustainability started monitoring the project for compliance with CDBG. In October, the managing agency against which complaints were made said they would turn the building and program over to another organization, which was the desired outcome of the CPO. A full report is available upon request.
- A client of a CDBG funded non-profit called the local newspaper to complain that the
 agency only provides a religious based financial management class. The CPO was
 contacted as part of an article about the issue. The non-profit said they now provide a
 secular class as well. For more information:

- The CPO worked with six community members with housing or other issues in 2015.
 Only one was a member of a protected class with a complaint about a local business. He did not wish to call the ADA complaint line.
- A notice was sent to all households and businesses (with a City of Loveland utility bill) advertising April as Fair Housing Month. The ad gave a phone number for the CPO should a resident wish to discuss a fair housing issue. This notice was sent to about 37,000 residents and businesses.

OTHER ACTIONS

- The City of Loveland has a contract with a translation service that provides written, verbal and in-person translation. To date, the CPO has not received a call from a non-English speaking resident, but is prepared in the event this should happen. The CPO also translated surveys, legal ads and parts of the Consolidated Plan into Spanish, and used in-service translation for public meetings.
- A Boulder based nonprofit, Audio Information Network, provided radio ads for sight impaired residents to increase citizen participation during the Consolidated Plan process in both English and Spanish.
- The Consolidated Plan Executive Summary and Goals sections were translated into Spanish and distributed locally.

- The 2015-2020 Consolidated Plan discussed place based investing as a means to cure substandard housing issues in low income and minority neighborhoods. The CPO hopes to produce a place-based investing business plan in collaboration with Habitat for Humanity in 2016 or 2017.
- The CPO took steps to diversify the two commissions that distribute City of Loveland and CDBG funds. While the Human Service Commission is now less diverse, the Affordable Housing Commission is more diverse.
- The CPO participated in the following webinars and trainings in 2015:
 - The History of Race, Racism, and Power in the United States, and How It Relates to Health Equity and HealthCare
 - Title VI for Loveland
 - You Do Need Both The Federal Law of Title VI and Language Access Plans
 - 80 Lb Pigs, Chairs & Effective Communications Americans with Disabilities Act 2014-2015
 - The Law of VRI 2 What About Those New Cases
 - Policy Directions in Affordable Housing (City of Fort Collins)
 - AFFH meeting conducted by Michele Hutchins.
 - Two meetings on City of Loveland Title VI and ADA compliance for managers occurred in June and November. Further trainings for all staff will happen in 2016.
- Information about how to attend public meetings and request assistance for a disability accommodation is now printed on all public meeting notices in English and Spanish. Public notices and ads say that meeting locations are physically accessible and provide both the State Relay number and TDD/TTY number when applicable.
- The Loveland City Council read a Fair Housing month proclamation in April.

Each of these actions will be continued into 2016 with further clarification and training for City staff and non-profit agency representatives.

A spreadsheet showing data missing from IDIS will be sent separately, including the number of clients served who report having a disability and the number of female headed households.

ACTUAL ACCOMPLISHMENTS COMPARED TO PROPOSED GOALS

A comparison of proposed goals from the Consolidated Plan and the 2014-2015 Annual Action Plan with actual numbers of low to moderate income households served during the reporting period can be found in the tables on pages 3, 4 and 5, and is described under *Assessment of Annual Progress* starting on page . The City of Loveland <u>always</u> distributes CDBG grant funding to area non-profit organizations to produce the results of the Consolidated Plan versus completing projects "in-house". If a local agency is not in a position to begin a new project that would impact Consolidated Plan results, funding is distributed based on the grant proposals received, with the highest priority going to projects that assist in meeting the five-year strategic plan.

During the 2014-2015 program year, worst case needs (defined as low-income renters with severe cost burden, in substandard housing, or involuntarily displaced) and accessibility needs of persons with disabilities were addressed by the listed organizations in the following manner.

- The House of Neighborly Service/Angel House program provided overnight shelter through churches, day shelter and case management at their office, and transitional housing at several locations in Loveland for homeless families.
 Neither of these programs were funded by the City of Loveland during the grant year so accomplishments are not available.
- The House of Neighborly Service/137 Connection program provided overnight shelter through churches when the overnight temperature was below 20 degrees, and day shelter and case management for homeless individuals. This program was not funded by the City of Loveland and accomplishments are not available.
- Catholic Charities of Larimer County, the Mission program, and the Fort Collins
 Rescue Mission provided overnight shelter and services to homeless Loveland
 residents throughout the year. Neither program was funded by the City of
 Loveland during the 2014-2015 grant year so accomplishments are not available.
- Alternatives to Violence provided transitional housing and case management for victims of domestic violence who would otherwise have to remain with an abusive partner or face homelessness. The transitional housing program was not funded by the City of Loveland during the 2014-2015 grant year so accomplishments will not be reported. Alternatives to Violence will start providing six weeks of shelter for victims of domestic violence in early 2016.
- The Loveland Housing Authority (LHA) manages the Housing Choice Voucher program in Loveland and as reported in the 2015-2020 Consolidated Plan, has 525 vouchers.
- The Loveland Housing Authority manages 665 apartment units, many of which offer subsidized rent to ensure that occupants are not cost burdened.
- Volunteers of America provided safety improvement repairs to help seniors and the disabled remain in their homes instead of having to move to an assisted living

facility or some other type of housing. This program provided services to 37 families during the grant year.

- Loveland Habitat for Humanity received a waiver of development and other fees totaling \$208,417 for nine for-sale homes in 2015, including a home for a survivor of the historic 2013 floods. The program makes home ownership affordable to low income clients, most of which were rent burdened prior to working with Habitat.
- The Loveland Housing Authority received a waiver of development fees totaling \$1,247,170 to build 70 units of multi-family rental housing for residents living between 30% and 60% of the AMI. Ten of the units will be set-aside for homeless veterans.
- The Housing Authority has two programs to help Loveland residents with rehabilitation of their homes, including the homes of disabled Loveland residents. The Larimer Home Improvement Emergency Program offers a grant of up to \$1,000 to help pay for emergency repairs such as a burst pipe or a broken furnace. This program is available to residents earning no more than 50% of the area median income. The Larimer Home Improvement Program provides low-interest loans of up to \$24,999 to residents at or below 80% of the area median income. The Emergency Program was funded during the 2014-2015 program year and assisted seven families during the grant year. Some of the funding remained unspent so additional families will be able to be served in 2016.
- Neighbor to Neighbor provided housing counseling to 519 Loveland households to prevent homelessness, stabilize families and promote self-sufficiency.
- Services were provided through the Sister Mary Alice Murphy Center for Hope located in Fort Collins, to families and individuals who are homeless or on the brink of homelessness. The mission of the Center for Hope is to help these families and individuals achieve stability and long-term self-sufficiency. This program was not funded by the City of Loveland during the 2014-2015 grant year and accomplishments are not available.
- Disabled Resource Services, Elderhaus Adult Day Program, Easter Seals/WINGS, Meals
 on Wheels, Audio Information Network, Senior Alternatives in Transportation (SAINT),
 Catholic Charities of Larimer County, Community Kitchen, Food Bank for Larimer County,
 Northern Colorado AIDS Project, Respite Care, and Rehabilitation and Visiting Nurses
 Association are local non-profit agencies that partner with the City to provide case
 management, housing counseling, housing, meals, and transportation to persons with
 disabilities, including seniors. Specific results produced by these agencies can be found
 starting on page 5. Some of these agencies were funded by the City of Loveland during
 the 2014-2015 grant year.

CONTINUUM OF CARE

During the 2014-2015 program year, actions taken to prevent homelessness, help homeless persons make the transition to permanent housing and independent living, and address the



needs of homeless persons and persons needing supportive housing, including persons with HIV/AIDS, are as follows:

- The CPO produced the fourth annual Loveland Homeless Connect on November 24th, a one-day, one-stop event to offer direct services from 45 organizations to our homeless and near homeless. 258 people attended the one day event. Some of the services offered include housing search assistance, overnight shelter information, first month's rent, a haircut and HIV testing.
- Homeward 2020, the organization behind the 10-year plan to end homelessness in Fort Collins, has continued to provide leadership for the Northern Front Range Continuum of Care. Homeward 2020's Director is working to ensure that homelessness is addressed regionally. The NFRCC is still working on various aspects of HEART Act implementation, and is currently leading the effort to implement Coordinated Access. Technical assistance will begin in the next few months.
- The Northern Colorado AIDS Project (NCAP) manages seven housing vouchers regionally and provides rental assistance for other clients. The City of Loveland funded the NCAP program during the 2014-2015 grant year.

In 2014, other actions specific to the areas listed above: PREVENTING HOMELESSNESS

- Rent assistance and housing counseling to prevent homelessness was provided to 519 Loveland households through Neighbor to Neighbor as noted above.
- Goodwill Industries opened a Career Center in Loveland to assist our hard to place job seekers, including homeless and near homeless individuals.

TRANSITION TO PERMANENT HOUSING:

- Transitional housing and case management was provided by Alternatives to Violence and the House of Neighborly Service/Angel House program. The City of Loveland currently has 29 transitional housing beds.
- Nineteen (19) Loveland residents currently have VASH vouchers.
- Almost 600 people were housed in low-income housing through the Loveland Housing Authority, including housing for disabled residents with support from Disabled Resource Services. 525 Housing Choice Vouchers were managed by the Housing Authority.

NEEDS OF HOMELESS PERSONS:

- Free tents, sleeping bags, coats, and other winter gear was given to the homeless through House of Neighborly Service/137 Connection.
- Free hot meals for the homeless and near homeless were provided by the Community
 Kitchen and the Front Porch Café. The Community Kitchen serves breakfast and lunch,
 and gives to-go bags of food to people unable to access food during the evening hours.
 The number of meals served by the Community Kitchen can be found on page 6. The
 Front Porch Café serves lunch and is not funded by the City of Loveland.



 Homeless shelter, meals, and case management was provided through House of Neighborly Service/137 and Angel House, and Catholic Charities of Larimer County.

HELP FOR PERSONS WITH HIV/AIDS:

 Treatment plans that included access to transportation, shelter, substance abuse and mental health assistance, and specialty medical care for persons diagnosed with HIV or AIDS was provided to 33 Loveland residents through the Northern Colorado AIDS project.

ADDRESSING OBSTACLES TO MEET UNDERSERVED NEEDS

The primary obstacle to addressing underserved needs continues to be an insufficient level of financial resources to impact housing, services for the homeless, and services for persons with low income, along with a consistent or an increased demand for services provided by many area non-profit organizations. Of particular need in Loveland is additional housing for very low-income residents and permanent supportive housing for our chronic homeless.

During the 2014-2015 grant year, the following activities addressed obstacles to meeting underserved needs:

- The City of Loveland invested \$500,000 of City general funds through the Human Services Grant program to assist persons with low income. See activities listed under *Public Services* starting on page 5 for a list of results produced during the grant year. In 2013, the Loveland City Council increased the grant amount from \$450,000 to \$500,000 and will consider increasing funding in the future based on need and inflation.
- Funds leveraged through the CDBG and HSC grant processes totaled more than \$14.2 million in Larimer County to produce the results listed on pages 3 through 7.
- In December 2012, the House of Neighborly purchased a new office building to allow the organization to expand services and accommodate another 12-14 non-profits all serving low income residents under one roof. The Community Life Center, "modeled after 19th Century Settlement Houses to encourage strong neighborhood communities by providing support for individuals, families and children by meeting basic needs and providing enriching activities for people of all ages", started serving people in the summer of 2014 with four organizations moving into the new space. Further expansion in early 2016 will provide enough space for the additional 3-5 organizations and will complete the project.
- In 2014, Alternatives to Violence purchased a house that has been rehabilitated to provide shelter for eight families that have been displaced by family violence. The shelter is expected to open no later than early 2016.
- Catholic Charities of Larimer County's Senior Services program ensures that low-income
 and at-risk seniors in Loveland stay independent and in their own homes for as long as it
 is safely possible. CCLC's Senior Services program offers no cost referrals and assistance
 applying for benefits and community resources, advocacy and representation on behalf
 of clients, translation/interpretation for Spanish-speaking clients, assistance accessing
 transportation, and comprehensive and progressive case management to seniors in



Loveland. The social caseworkers can work individually with seniors in their homes and provide ongoing support to ensure they remain housed and stay connected with health care providers and community resources.

FOSTER AND MAINTAIN AFFORDABLE HOUSING

The City of Loveland generally invests a substantial portion of allocated CDBG funding to maintain housing as affordable by assisting organizations with rehabilitation. Over the last five years, \$385,293 was used for housing rehabilitation. If these organizations had to pay for the rehabilitation, a portion of the cost would likely be passed on to the occupant of the housing unit.

The office of Development Services of the City of Loveland has been discussing a program to assist for-profit landlords rehabilitate homes for low-income individuals or families in a manner that will keep the rents affordable for many years. Although the program has not yet been funded, additional organizations have joined the conversation and the work may occur as part of place based investing under the new Fair Housing Rule and was discussed in the 2015-2020 Consolidated Plan.

ELIMINATE BARRIERS TO AFFORDABLE HOUSING

The City of Loveland provided development and building permit waivers and reductions to help create nine units of new affordable single-family housing and 70 units of multi-family housing for a total investment of about \$1.46 million. Development and permit fees are often cited as a barrier to affordable housing.

In addition, \$100,000 of CDBG and \$10,423 in fee waivers were used for the safehouse project, \$70,000 of CDBG was used to purchase land for four Habitat for Humanity homes, and \$21,342 was used for housing rehabilitation to help keep people safely in their homes.

OVERCOMING GAPS AND ENHANCING COORDINATION

The City of Loveland works closely with all major non-profit human service agencies in Loveland, the Loveland Housing Authority, local developers and builders, and other entities providing funding to non-profits and affordable housing developments. Over the past year, in addition to working with these groups, the Community Partnership Office partnered with the following groups to jointly address community issues, specifically poverty and homelessness:

- United Way of Larimer County/Community Impact grant committee member to review proposals submitted by agencies working to create health for families.
 Continuing work on Community Impact committee to understand agency collaborations and working together to reduce poverty.
- Northern Front Range Continuum of Care to address homelessness, affordable housing, and greater regional collaboration in the implementation of the HEARTH Act as described on page 13 under Homeward 2020. The NFRCC also collaborated on the Point-in-Time (sheltered) count that was held on the evening of January



27, 2015. In Loveland, the count showed that 56 homeless individuals slept in two churches or transitional housing, and 54 people were living on the streets or someplace not meant for human habitation.

- Larimer Home Improvement Program Board of Directors to provide low-income loans for housing rehabilitation, and funding in the case of an emergency.
- Emergency Food and Shelter Program Board to ensure that Loveland organizations receive adequate representation and financial assistance from this funding source.
- Coalition for Activity and Nutrition to Defeat Obesity (CanDo) strategic plan committee member to support work around active living as it pertains to low income households and to better understand how to impact health through the built environment and City of Loveland policies.

IMPROVING PUBLIC HOUSING AND RESIDENT INITIATIVES

The City of Loveland does not own or operate public housing. The Loveland Housing Authority manages just under 600 housing units on 11 properties in Loveland. While these units are not technically considered public housing, the Housing Authority provides most of the rental housing for low-income Loveland residents.

The Loveland Housing Authority works to improve the living environment of residents through activities and events that are planned by their Resident Advisory Board. The board is comprised of representatives from each of the Housing Authority properties who want to assist with decision making and policy development. They also review applications for a local scholarship program and host gatherings at each of the Housing Authority properties. Most properties have between two and four events a year.

REDUCING LEAD-BASED PAINT HAZARDS

All recipients of CDBG funding through the City of Loveland are required, by legal contract, to comply with lead-based paint requirements as a condition of receiving grant funds, unless the project is, and will remain, senior-only housing. When an activity involves a housing purchase, rehabilitation or any other activity covered by lead paint regulations, the CPO educates the grant recipient on the requirements for testing, and if necessary, abatement and clearance. Due to limited CDBG funds received by the City of Loveland, the city also informs all grant applicants of the lead-based paint regulations prior to any award being made, as the expense of complying can sometimes prohibit an activity from being completed.

The house purchased by Alternatives to Violence to provide shelter for victims of domestic violence has extensive lead paint that was mitigated in 2015. Prior to allowing residents, the CPO will provide additional information about the hazards of lead paint to staff members working with people as they enter the safehouse program.

ENSURING COMPLIANCE WITH PROGRAM AND COMPREHENSIVE PLAN REQUIREMENTS

The City of Loveland does not accept CDBG applications for projects that do not meet CDBG eligibility requirements or Consolidated Plan requirements. In addition, all projects must comply with the City of Loveland Comprehensive Plan.

REDUCING THE NUMBER OF PERSONS LIVING BELOW THE POVERTY LEVEL

The City's effort to reduce the number of persons living below the poverty level include:

- Providing grant funding to low income Loveland residents through the Human Services Grant Program. Grants are allocated to support agencies that provide food, shelter, physical and mental health care as well as services that prevent crises, and assist in sustaining independent living, all of which addresses issues of poverty.
- Housing assistance provided through projects and programs receiving funding through the City, including housing counseling and rehabilitation. Over the last five years, funding was also used for rent assistance and affordable home ownership.
- The CPO sits on the United Way Loveland allocation committee to participate in conversations and programs that address poverty in Loveland. United Way is committed to reducing the number of people in poverty by 50% by 2025.
- The Loveland City Council allocated \$1.46 million in fee waivers in 2015.
- The Matthews House Empowering Youth Program serves youth ages 16-21 who are either homeless or lack significant family support in their lives as they transition into adulthood. The program helps youth with life skills, including cooking and nutrition, money management, anger management, employment readiness, parenting skills, health, and substance abuse and prevention. The City funded both the Matthews House program and will provide \$20,000 in 2015-2016 toward an office space in Loveland to make services more convenient for Loveland youth.
- The City of Loveland is creating the next ten-year Comprehensive Plan (<u>www.createloveland.com</u>). The CPO worked with the Strategic Planning Department to expand Citizen Participation to include more low-income and Spanish speaking Loveland residents.
- The Economic Development department in the City of Loveland is dedicated to bringing primary employers to the City to support ongoing economic growth, thereby providing for employment opportunities at all income levels.

LEVERAGING RESOURCES

CDBG funds are key to leveraging other public and private resources to address needs, and often leverage state housing funds, CDBG funds from the City of Fort Collins, HOME pass-through dollars, local foundations, and many private sources. The table below shows the amount and type of other funds leveraged for programs in which City of Loveland CDBG funding was spent.

The \$500,000 funding contributed to the grant process through City of Loveland leverages an additional (approximately) \$9.8 million for Loveland based programs. These programs produced the bullet item list of results starting on page 5.

CITIZEN COMMENTS

The 2014-2015 CAPER was available to the public for comment from December 16, 2013 through December 30, 2015. Copies were available at the City of Loveland CPO Office and the CPO website. No comments were received.

SELF-EVALUATION

The City of Loveland's CDBG funds assisted the community in making an impact on identified affordable housing and homeless needs: 44 families were assisted with housing rehabilitation, 3,352 people received food and other assistance at the new Community Life Center, 427 people who escaped domestic violence received support, and 33 people diagnosed with HIV or AIDS received case management. Other city funds granted locally assisted tens of thousands of Loveland residents outlined under Goal #3.

Not all of the goals that were submitted with the 2010-2015 Consolidated Plan will be met, as described on page 7. With about \$200,000 in CDBG/Bricks & Mortar funding, the City of Loveland is unable to provide much financial support for any major housing project. Instead, we are continuing to focus on maintaining and strengthening our partnerships and looking for opportunities for new partnerships to better address needs, including the dire need for affordable housing for people living at 30% AMI, and Permanent Supportive Housing for many of our chronically homeless.

CHANGES IN PROGRAM OBJECTIVES

While the overall program objective did not change during the program year, the use of funds did. For more information, see page 5, *Changes in Funding Distribution*.



CARRYING OUT CERTIFICATIONS

The City of Loveland CPO remains consistent with the Consolidated Plan by granting funding to agencies providing services to homeless individuals and families, and providing affordable housing or housing rehabilitation to low/moderate income households. CDBG funding is accessed through a grant application process. All applications for CDBG funds are reviewed by volunteer commissioners who make funding recommendations that are reviewed, and ultimately adopted, by the Loveland City Council. The volunteer commission is aware of the goals and objectives of the Consolidated Plan and makes funding decisions appropriate to long-term goals. The City also pursues sub-recipients that have the capability and capacity to seek other resources to propose viable projects and activities.

As noted, in addition to distributing CDBG funding, the City of Loveland CPO also distributes \$500,000 of general fund dollars, which also partially addresses the goals of the Consolidated Plan. This funding and allocation process is similar to the CDBG funding process.

The City of Loveland follows all U.S. Department of Housing and Urban Development requirements, including Certifications of Consistency. Certifications of Consistency are provided to organizations seeking other funding for activities that meet the goals of the Consolidated Plan and the needs of households with low income.

COMPLYING WITH 70% LMI BENEFIT

CDBG funds were used exclusively for activities benefiting low to moderate income persons to meet national objectives.

ANTI-DISPLACEMENT AND RELOCATION

None of the 2014-2015 CDBG activities involved or resulted in displacement or relocation.

ECONOMIC DEVELOPMENT

CDBG funding was not used for economic development. Economic development is not a part of the current Consolidated Plan.



FINANCIAL NARRATIVE

PROGRAM INCOME

The City of Loveland Community Partnership Office does not collect program income.

Page 4 of the City of Loveland sub-recipient contract reads:

15. <u>CDBG Fund Income</u>. The Subrecipient shall pay all income generated from CDBG funds to the City's CDBG Program. In the event the City allows the Subrecipient to use the income for other CDBG activities, the Subrecipient shall do so in accordance with the provisions of this Contract, which shall apply to such use. Program income that is acquired by the Subrecipient must be expended prior to any grant funds used for the same purpose.

Should a CDBG funded program discontinue services, the City of Loveland will require that program income be returned to the City as long as income is continuing to be generated.

GENERAL FINANCIAL INFORMATION

At the beginning of the program year, the CPO had \$376,888 CDBG funding: \$270 from a prior year, \$74,970 that had previously been returned to HUD for an ineligible project and \$301,648 received for 2014-2015. By the end of the grant year, \$13,803.29, or 3.7% remained unspent.

The Community Partnership Offices does not participate in or does not have:

- Revolving loan fund
- Float-funded activity
- Lump sum drawdown agreement
- Income received from the sale of a property
- Property owned by sub-recipients with CDBG funds that is available for sale
- Neighborhood Revitalization Strategy (NRS) area

CDBG FUNDING SPENT ON REHABILITATION

Funding spent on rehabilitation activities during 2014-2015 can be found on page 4 under Rehabilitation: 44 units of housing were rehabilitated during the program year.

- The Loveland Housing Authority received \$16,342 (spent \$7,539) for the Larimer Home Improvement Program Emergency Grant (LHIP EM). Seven families received grants for furnaces and water heaters.
- Volunteers of America received \$5,000 and rehabilitated 37 homes with grab bars, handrails, chair platforms, wheelchair ramps, and other home maintenance needs to allow seniors to remain in their homes.

1st Qtr - After trying many times to leave her abuser, M finally did; but this happened after her three children almost lost their lives in a car accident! The children were riding in the Jeep with their father who was driving under the influence of alcohol. His impairment caused the Jeep to flip over. M and her children now reside at the ATV Transitional Living Center and she shared with her case manager that her abuser has been on probation many times for driving while intoxicated and he must wear an ankle bracelet. M states. "When he is wearing the ankle bracelet, he doesn't drink. But as soon as the ankle bracelet is removed, he drinks and behaves like an animal and he doesn't care about anything." After approval to occupy a unit at TLC, M secured a Restraining Order against her husband; she and her children moved out of the family home. M feels guilty for staying with her abuser for so long because he has caused their children psychological harm. M states that her oldest son draws angry dolls, sad dolls, crazy dolls on his hands or on paper and hides the drawings from her. Her other child is six and is now wetting the bed. Both children are receiving clinical services with individual therapy. M and her children are slowly learning how to live without their abusive father; learning that violence and alcohol are not an every day event; and learning that without violence they can enjoy hope and happiness.

2nd Qtr - The tenant who recently moved out of the TLC remained in residence for more than a year. During that year, she secured employment and child care for her children. She and her children are temporarily in an apartment; she is able to meet the monthly financial obligations of her family.

3rd Qtr - Domestic Violence drove E and her 2 children to their car to live until they found ATV. ATV was able to help them at that time by paying for a motel for a few nights prior to receiving two-year transitional housing. They are now exiting the program and E has stated that the she was able to heal the physical and emotional wounds of domestic violence during that time. E has a stable job and she has learned how to budget. She was able to pay for her car in full while she was in the program so no longer has to worry about having reliable transportation. 2013 1st qtr - executed contract. Almost all of our homeless have been working on staying sober this winter. Many of them blow 0 when we breathalyze them at the beginning of the night. 137 have manage to stay open without any incidents this winter.

2nd qtr - Dallas came to us in November of 2013. We did an intake and assessed his needs for shower, laundry, locker, homeless gear, and safety. Over time we had many conversations and mentored Dallas and encouraged and believed in him and brought him into our New Life Program. In the past couple of months he got a job and most recently he got a room where he is proud to be able to pay rent. He comes back to check in with us and let us know what is going on in his life.

3rd qtr - Angelina came to us in March of 2014. We did an intake and assessed her needs for shower, laundry, storage, homeless gear, and safety. We also discovered her interest in gardening so we helped supply the tools so she could start plants. We brought her into the New Life Program where she continues to follow through with the gardening out back. She really wanted to get off the streets and found a temporary place to couch surf. Recently her name came up with Housing Authority and we continue to advocate, council and be a friend and stay connected.

4th qtr - Kim came to 137 in March of 2014. She wanted to get into the New Life Program but she didn't follow through with the requirements to do so. The first step in getting into the NLP is writing a one page essay. Kim had lots of resistance in doing this until we discovered she needed assistance with the essay. She was able to complete the essay which was followed by goal setting. One of the goals was to get all of the necessary paperwork together for housing. During this time we helped her obtain her SS card, ID, bus passes and eventually a disability bus pass. Another goal Kim set was to give back to the community by becoming a volunteer at 137 or working with the elderly. By helping Kim stay connected with her disability and housing paperwork, she has now been accepted into housing with Section 8 and will move into her place within the next week or two. Through the NLP, Kim will also be a volunteer soon.

She fought and won custody and found herself with many car problems that kept her from taking her children to school and herself to the doctor. Her counselor has helped her with the emotional scars and continues to do so but she also requested funds from a local group to provide help with repairs for her car. She was also provided a wonderful Christmas for her kids with gifts of clothes, toys and a gift card. Her health is still declining but her stress level has decreased enough to give her a better chance of making her healthy enough to make lasting memories with her children with the time she has left.

Q3 - G came to ATV after years of severe abuse from her husband and family. After two years of hard work in therapy, she's going to school, has an apartment, and has made significant progress healing.

3rdQtr: ÿ¢Ã¿Â¿Â¿Â¿ÁçÁ¿ÁçÁçÁçÁçÁçÁçÁçÁ;• has been HIV+ for more than 20 years and has been living in our service region on and off for the past 10 years. JoeÿÁ¢Á¿ÁçÁçÁçÁçÁcs case manager was able to connect him to resources available and provide financial assistance to help pay for his medication and physician visit co-pays as he was living off a small fixed income. Joe currently accesses multiple services at our office including individual mental health counseling, group-level mental health services, food assistance and financial assistance. A goal that Joe is working with his case manager is to be able to go back to work part-time to become more self-sufficient.

4thQtr: A client who has been enrolled in case management services at NCAP since 2010 was recently in a serious ATV accident that landed him in the hospital for 11 days; he is healing well but is still experiencing moderate levels of pain. As a result of the accident and future-mounting hospital bills, he was unable to pay his rent for October. He requested NCAPÿ¢Ä¿Â¿A¿A¿s assistance in relieving this financial hardship and NCAP was able to pay his full monthÿ¢Ã¿Â¿Â¿Â¿Açs rent, which will allow him to keep his current living situation and will alleviate some financial burden from medical bills.
