-Boulder and Loveland are two communities in Colorado who are experiencing the highest economic recovery

b. Staff Liaison-Beth Gudmestad

i. GrandFamilies Event Update

No families actually came to the event, YAC members would be interested in doing this program in the spring if people are willing to show up.

c. City Council Liaison-Phil Farley

-City Council approved the 2015 Budget. It took 15 – 20 hours to go through the budget.

-City Snapshot: the general fund has a surplus of 12.9 million dollars, sales taxes are up and expenditures are down

-Shared percentages of unemployed throughout the state:

- Overall Colorado has an unemployment rate of 4%
- Larimer County has an unemployment rate of 3.2%
- Loveland has an unemployment rate of 3.6%

-North Front Range Metropolitan Planning Organization (NFRMPO)

- Emphasis on fixing I25 - expanding it to three lanes all the way from Denver to north of Fort Collins. The total cost is estimated at \$1B; The NFRMPO agreed to fund \$5M to rework the Crossroads inter change and to put in a truck lane on the “Berthoud Hill”.

-Loveland Fire Authority is investigating requiring Fire sprinklers in all new construction including Duplexes, Town Homes, and Multi-Family Homes single family, detached housing will be excluded.

- fire authority is taking a look at how much it would cost

-Establishment of Downtown Development Association (DDA)

- The City will hold a special election in February (voters would be property owners/business owners and residents living in the downtown area) They'll be first voting on forming a DDA and in November they will have another vote on how much to tax themselves

-The city finalized the Hach incentive,

-The city approved on first reading to provide a \$2.2 million dollar incentive to Evergreen Development for them to build a Sprouts store which will be paid back in 6-10 years; in fifteen years the estimate is \$8-12 million in tax revenue from Sprouts in excess of the \$2.2M incentive.
