STUDY SESSION

1. FCC Code Amendment (Troy Bliss and David Eisenbraun)

On April 8, 2015, the Federal Communications Commission (FCC) implemented new rules that impact collocation, modification, and replacement of wireless facilities along with limitations on the time allowances for processing of applications by local governments. In order to integrate the new regulations into the Loveland Municipal Code, City Legal has drafted a new section within the existing wireless code provisions. This amendment will help ensure that future placement, construction and modification of personal wireless service facilities are met with efficiency and consistent interpretation. Staff is seeking any comments Commissioners may have regarding the proposed code changes.
