**SUBMISSION OF BOND PURSUANT TO CRS §1-11-203.5(1)**


Comes now the Contestor, Larry Sarner, *pro se*, to submit a bond to the Court in the above-captioned contest.

1. On August 25, 2016, the Contestor filed a petition with this Court pursuant to CRS §1-11-205.3, contesting two ballot questions set by the Contestee, City of Loveland.
2. CRS §1-11-205.3(1) has a requirement for filing a bond in this contest. The statute say, in relevant part:

Before the district court is required to take jurisdiction of the contest, the contestor shall file with the clerk of the court a bond, with sureties, running to the contestee and conditioned to pay all costs, including attorneys fees, in case of failure to maintain the contest. The judge shall determine the sufficiency of the bond and, if sufficient, approve it.

3. The Contestor hereby submits a bond amount of \$50.00, with sureties, running to the Contestee and conditioned to pay all costs, including attorneys fees, in the event the Contestor somehow manages to fail to maintain the contest.


