POLICE CITIZEN ADVISORY BOARD  
SEPTEMBER 12, 2016  
TRAINING ROOM

Present: Chairperson Pat Kistler; Tony Adams, Bev Cardarelli, Erin Frisch, Ed Gassman, Dick Hunsaker, and John Tindall; Chief Bob Ticer; Councilor Hugh McKean; Dana Rieck – Reporter Herald; guest Don Wubben and Elizabeth Markham

The meeting was called to order at 5:40 PM by Chairperson Pat Kistler. A motion was made and seconded by Ed Gassman and John Tindall respectively to approve the minutes as is. Motion carried.

CHIEF TICER

- Chief Ticer gave a brief overview of some of his plans for the department especially in traffic safety. Chief has met with several divisions within the department as well as individuals to get and give their perspective on ideas and sharing them with other department divisions.
- Chief Ticer has set the vision for the police department and they consist of three (3) goals:
  - Reduce crime and fear of crime
  - Traffic Safety
  - Educate the community
- Chief stated that in 2015 there were 2100 car crashes in the City of Loveland. That is one of the reasons why the community needs to be educated on traffic safety. First and foremost officers will get the highest training possible for tactics and leadership.

One board member asked how the PCAB can help and Chief Ticer indicated to focus on the above mentioned goals.

- Chief Ticer asked for the Board's support for the following new positions:
  - 1 sergeant
  - 2 Communications Specialists
  - 1 Records Specialist
  - 1/2time Investigative Technician
- Chief Ticer spoke briefly about the training facility. City Council has asked us to explore other options that could be possible. Chief gave information to City Manager Steve Adams. Indicated Fort Collins is still interested in the training facility and if it does come to fruition it most likely will be developed into phases.
- Front Range Community College is looking to start a POST academy in 2017. LPD will be able to put instructors at FRCC to help with the academy. **Board member Gassman asked where FRCC stands at this point.** Chief indicated that they are moving forward.
- Chief THANKED Dana Rieck and the *Loveland Daily Reporter Herald* for the great relationship that we have. **Board member Cardarelli THANKED Dana for the recent article that was put in the paper by Chief Ticer.**

PCAB Member Comments

- ❖ John Tindall presented to the board the update on the police pension plan which will hopefully be presented to City Council in October. **Chief Ticer sees this new pension plan proposal as a**

**strong recruiting proponent as well as retaining officers.** John indicated that the new proposal will be 55 years old for an officer that can now retire. **Chief stated that he appreciated John's membership on the police pension board.** Councilor McKean indicated that it was important to have the age pulled back to 55. **Board member Cardarelli said it was important to have the presented to the City Council again.**

#### COUNCILOR McKEAN'S UPDATE

- Had nothing to report but did indicate that he was available by phone or e-mail if any board members needed any information or had concerns.

#### GUEST DON WUBBEN

- Stated that he had some concerns with the police department but after his explanation of the issues it was decided that Chief Ticer would meet with him at a later time.

There being no further issues to discuss a motion was made and seconded by Ed Gassman and Tony Adams respectively to adjourn the meeting. Motion carried. Meeting adjourned at 6:35 PM.
