POLICY CHANGES in regards to

Definitions: 2017 Policy Change: Peak time is defined as Saturday and Sunday from first tee time until noon during May 01 – September 30.

General: New Food and Beverage: 2017 Policy Change: The Food and Beverage Concessionaire has exclusive rights to sell, serve, and distribute food and beverages to the general public and patrons of the golf course or clubhouse on, at, or from the Premise or Concession facilities. Patrons, including but not limited to, tournament participants or organizers, program participants or organizers, or members of the general public are prohibited from bringing any food or beverage items onto the course for any reason except personal consumption, without written permission of the Food and Beverage vendor.

POLICY CHANGES in regards to

Advanced Reservations: *1. ... Singles will be provided an advanced tee time if they can be paired with a twosome or threesome currently holding a reservation.*

2017 Policy Change: ...Tee times will be made in advance for single players with the following guidelines: If a single player calls to make an advanced tee time all attempts will be made to schedule them with a 2 some or 3 some. If that isn't an option they will be scheduled by themselves. Further:

Definitions and Process –

Golfer with a reservation – A golfer that comes to the golf course with a reservation

Walk-on Golfer – A golfer that comes to the course without a tee time and wishes to play a round of golf. A walk-on golfer can reserve a tee time by talking to the starter but must pay the front desk, or can choose to play on standby status. If a walk-on golfer gets a reservation – they are no longer playing on Standby Status.

Reservation – When a golfer is assigned a tee time (starting time) for a certain number of players. Most golfers will reserve a tee time before arriving at the golf course. Some golfers may walk-on to the golf course without a reservation. When walk-on golfers are added to the starters tee sheet and assigned a tee time, they now have a reservation and will be expected to tee off at their reserved tee time.

Standby Status – Some golfers will walk onto the golf course without a reservation and will desire to be paired into the next available tee time. This ready to play status is called Standby. Standby golfers will be paired into groups with less than 4 players.

Day of play

Single player calls in for a tee time schedule them on the tee sheet and call the starter so the reservation is also added to the starters tee sheet. If the tee time they are making is within 1 hour call the starter to confirm the time is available (the starter may have assigned open reservations to other walk-on golfers). If a time is available, keep the player on hold until you can make sure the starter writes his name down on the starting sheet.

POLICY CHANGES in regards to

Golf Cart Use: Private Carts

2016: Individuals may use their own, private golf carts at any of the three courses provided all appropriate fees have been paid, the golf cart is electric (or has been pre-approved by Golf Manager) and has a valid permit for that course displayed in the front lower right-hand corner on the face of the golf cart. Individuals permitted to use private golf carts are subject to the same rules of operation set forth above, as well as those additional rules stated below.

2017 Policy Change: Individuals may use their own, private golf carts at any of the three courses provided all appropriate fees have been paid, the golf cart is electric, has 4-wheels, weighs in excess of 500 lbs, dry weight without batteries, and has a valid permit for that course displayed in the front lower right-hand corner on the face of the golf cart. Individuals permitted to use private golf carts are subject to the same rules of operation set forth above, as well as those additional rules stated below.

POLICY CHANGES in regards to

Twilight & 3-Hole Round Golf

2017 Policy Change: Sunset Rate: Sunset rate golf is limited to The Olde Course at Loveland and offers a discount from the normal daily green fee. The first tee time for the sunset rate will vary within the season based on available daylight; the rate is designed to allow players to play as many holes as possible before dark. Both

walking and riding rates are applicable. Any player abusing the privilege of Sunset Rate golf will have those privileges revoked and will be subject to suspension from the course.

Tournament and Group Events/Prizes, Food and Beverages
