Chairperson Pat Kistler called the meeting to order at 5:35 PM. A motion was made and seconded by Dick Hunsaker and Dennis Soucek respectively to approve the minutes. Motion carried. Approved.

CHIEF TICER

- ❖ Chief Ticer invited everyone to the LPD 2016 awards ceremony on February 17. Chief mentioned that officers over 20 years are becoming Master Police Officers and sergeants with 10 years or more as a sergeant will become Master Police Sergeants. This is new and recognizes the years of service that these officers have put in. Chief stated his awards reflect on *Save Lives, Fight Crime, Survive*. The Chief's personal awards reflect on reduce crime and fear of crime; traffic safety and community education and are named Crime Fighter of the Year, Traffic Safety Officer of the Year and Community Education Officer of the Year. Chief also reflected on what the new Value Statement of the Department is. RISE: Respect, Integrity, Service and Excellence.
- ❖ Chief Ticer asked PCAB members if they would like to have an open agenda and they thought that it might be a good idea.
- ❖ Chief spoke briefly on his meetings with Chief of Police John Hutto of Fort Collins regarding the Regional Training Facility. Both the City of Loveland and City of Fort Collins are looking at reviewing the original concept design. This design will be presented to City Council on the February 21 with an information presentation, which is to include operational/maintenance costs, reduction in current training costs and information on potential lease/option/rental use by other agencies. Chief THANKED the members of PCAB for their support and presentation of a letter to the City Council indicating such. Council Overcash stated that previously all councilors asked Chief Ticer to move forward with additional information that is to be presented February 21, including financial information. Chairperson Pat Kistler THANKED Councilor Overcash for his support on the Regional Training Facility.

- ✓ PCAB members Tindall and Frisch reviewed CARs for the 3rd and 4th quarter of 2016 to select their person(s) for the Above and Beyond Star Award and chose Nate Schadewald and Ken Smythe. These two awards will be presented at the 2016 Awards Ceremony on February 17.
- ✓ PCAB member Cardarelli asked about the comments in the paper on Traffic. Chief Ticer explained that there were a few errors but that he and others will be working with the Reporter Herald staff for correct statistics. Chief's priority is traffic safety in the community.
- ✓ PCAB Chairperson Pat Kistler will be out of town at the next meeting and John Tindall as agreed to chair that meeting.

- ✓ PCAB member Dick Hunsaker stated he has not yet received his new ID picture. Elizabeth is to check on this.
- ✓ PCAB member Kathy Mitchell will be getting her picture ID taken on February 17.
