POLICE CITIZEN ADVISORY BOARD MEETING
MARCH 6, 2017
TRAINING ROOM

Present: Capt. Brown (Acting Chief); Tony Adams, Bev Cardarelli, Erin Frisch, Dick Hunsaker and Dennis Soucek. Councilor Don Overcash and CSO Nate Schadewald

PCAB Member John Tindall called the meeting to order at 5:40 PM. A motion was made and seconded by Dick Hunsaker and Bev Cardarelli respectively to approve the minutes. Motion carried. Approved.

CSO Nate Schadewald attended the meeting to thank the members of PCAB for the "Star Award" that was presented at the awards ceremony in February. Nate also spoke a little bit about himself and some of his duties, which include: passenger transports, traffic accidents, cold calls and parking enforcement. Capt. Brown complimented Nate on his work which is always above and beyond his normal duties. In 2016 he received a citywide award in helping with the I.D. program. Nate worked with the City Attorney's Office to modify an ordinance for abandoned vehicles.

- ❖ Capt. Brown spoke about the DDACTS (Data Driven Approach to Crime and Traffic Safety) system that the Loveland Police Department has started using to monitor traffic safety and criminal activity. This new program will help us to establish and move forward in the aforementioned process. Highway 34 is a section where a lot of accidents and shoplifting occur. DDACTS is an intelligence gathering process wherein target data is given to us. LPD has started to compare data for the past three years which include traffic charges, vehicle trespasses and shoplifting. LPD officers are working proactively on the East Eisenhower corridor to be more visible in an attempt to deter crime. Comments have been received from citizens appreciating the high visibility in this area. PCAB member Soucek asked if it is a benefit to the police department is a citizen notices vehicles to call it in. He also stated that there are citizens that would be willing to sign complaints. Captain Brown indicated that it is extremely helpful when citizens engage themselves on issues such as this. If a citizen calls in the Communications Specialist on duty will ask that person if he/she are willing to sign a complaint or if an officer can contact them. PCAB member Adams asked if officers are going to be getting in-car cameras. Capt. Brown stated that Panasonic arbitrators are our cameras.

PCAB Member Comments

- ✚ PCAB member Adams asked about the I-25 and Hwy 402 widening. Councilor Overcash stated that the City is working on an agreement with CDOT and Johnstown regarding upgrading the section at I-25 to three lanes.
- ✚ PCAB member Cardarelli asked about the issue concerning Sgt. Chase. Capt. Brown indicated that is a personnel matter and could not be discussed. Capt. Brown did state that officers are working as *OFFICERS IN CHARGE* to take over sergeants duty when needed.
- ✚ PCAB member Frisch attended the R2J Wellness program which was extremely informative. She stated that parents learned about mental health issues with children and parents and internet safety. Jennifer Tracey as well as Sgt. Pyle spoke. Erin complimented Sgt. Pyle on the great job he did.
- ✚ PCAB member Soucek asked if LPD was still involved with ATV. Captain Brown stated that we are and they are a great asset to the community.
- ✚ PCAB member Adams spoke about a bill in the state about approving concealed weapons permits without classroom or firearms training.
- ✚ PCAB member Hunsaker commended the great job by everyone on the awards ceremony.

There being no further business a motion was made and seconded by Dennis Soucek and Tony Adams respectively to adjourn the meeting. Motion carried. Approved. Meeting adjourned at 6:33 PM.
