Procedure:

The application procedures are as follows:

- Application for reimbursement must be within one year of completing the incident.
- The application can be obtained at www.epa.gov/superfund/programs/er/lgr or by calling 1-800-431-9209.
- The following criteria must be met in order to apply:
 - LFRA responded to a release or threatened release of hazardous substances, pollutants or contaminants to the environment.
 - LFRA does not have money in the budget for the response.
 - LFRA is not responsible for the release.
 - LFRA was unable to recover the costs from the responsible party for the release, from the State of Colorado or from the local government insurance company.
- According to the above, the Loveland Fire Rescue Authority has the right to recover any costs incurred in response to a hazardous materials incident. Any expenses associated with hazardous materials response that are assessed by the Loveland Fire Rescue Authority are separate and removed from any other costs or fines that may be ordered on the responsible party by Federal, State and/or Local government entities.

The following procedures will be followed during and after a hazardous materials incident:

- Making the determination to bill the Responsible Party
 - Throughout the course of any given year, several minor hazardous materials incidents take place that do not require a cost recovery process. As such, two categories for cost recovery are hereby established:

- Ordinary operation. This involves the day-to-day hazardous materials incidents where less than \$50 worth of equipment is either used or damaged. No attempts will be made to recover costs for ordinary operations.
- Extraordinary operation. This involves any hazardous materials incident where more than \$50 worth of equipment is used; either damaged or contaminated. Loveland Fire Rescue Authority will make every attempt possible to recover costs under these conditions.

Establishing Equipment Inventory utilized

O An inventory of all equipment and or supplies used and/or expended at an incident will be documented on the *Inventory of Expended Equipment* (Table 1) form by personnel on scene of the incident. This documentation will be forwarded to the Special Operations Team hazmat coordinator. It will be the responsibility of the Hazardous Materials Rescue Group Supervisor or designee to assure this documentation is complete.

Billing Procedure

- Upon completion of the NFIRS, the incident commander will forward a copy of the report and the *Inventory of Expended Equipment* form to the Special Operations Team hazmat coordinator or designee. This will take place no more than 48 hours after the incident has been terminated to ensure that a timely billing process is accomplished to replenish lost supplies and equipment.
- Responsibilities of the Special Operations Team hazmat coordinator or designee:
 - Upon receipt of the proper paperwork, the coordinator will complete the Haz Mat Billing and Cost Recovery form (Table 2) to determine if the costs are either ordinary or extraordinary as defined above.
 - o If the costs are ordinary, the *Haz Mat Billing and Cost Recovery* form will be filed for future reference and no further action will be taken.
 - o If the costs are extraordinary, then all attempts will be made to recover lost, damaged or contaminated equipment.
 - Equipment costs will be based on replacement cost and not determined by the purchase price.
 - o Costs for apparatus and personnel will be based on the Fee Schedule (Table 3).
 - Cost recovery for personnel will be based on whether the incident has a duration of two
 or more hours. This not only includes on-scene paid members, but also those who are
 back-filling vacant stations.
 - O Due to the constraints of the Fair Labor Standards Act (FLSA), Loveland Fire Rescue Authority cannot recover personnel costs associated with Reserve Firefighters.
 - Upon the completion of the inventory sheet, Table 2 and Table 3, all information pertaining to the incident and the recipient of the bill needs to be filled out on the Hazmat Billing Information form (Table 4).
 - The completed package will be forwarded to the battalion chief of Special Operations for review within 48 hours to expedite the timely replacement of lost equipment and supplies.
 - Upon acceptance by the battalion chief of Special Operations, the package will then be forwarded to the Loveland Fire Rescue Authority Business Services Coordinator for billing.

- Should the need arise to make application to the Environmental Protection Agency's local government reimbursement program, all required steps will be followed. Please refer to the EPA Internet site or call the toll free number listed above for assistance. Reimbursement of funds for incidents occurring in mutual or automatic aid areas.
- For incidents occurring while operating with mutual aid hazardous materials teams, the Special Operations Team hazmat coordinator or designee will submit the appropriate paperwork described above to the Designated Emergency Response Authority (DERA) responsible for the incident.
