GUEST SPEAKER, Jessica Hinterberg of "CanDo" program, provided information on Healthy Habits for Healthy Families Program. The mission is to improve the healthy eating habits and physical activity of the community. Supported by Live Well Colorado, twenty-two Colorado communities are participating. Loveland started this program 3 years ago, with the support of Banner Health McKee Medical Center and Poudre Valley Hospital. ## **UNFINISHED BUSINESS**

CITY COUNCIL UPDATE (Daryle Klassen) Discussion about the attempt to request a second reconsideration of funding for Disability Resources, unsupported once again by the Human Services Commission. There is difficulty in deciding the funding requests for the \$900,000 needed with only the available amount of \$500,000. Diane Hinrichs has offered to keep this board apprised of Disability Resource status. On the issue of Medical Marijuana, 19 sites so far, the moratorium continues. This issue will go to a vote by the people in September. Council is looking to FEMA for Job creation funds.

The SENIOR NETWORKING EVENT-"Bridging the Gap"-will be held at the Fountains in Loveland. Phoebe Hawley will sum up presentation at our July meeting.

## **NEW BUSINESS**

VITA PROGRAM-Larry Roos handed out the Volunteer Income Tax Assistance report of the 2009 tax returns prepared in 2010. In the Loveland area, 1,080 returns were prepared, majority were filed electronically. Volunteers consulted with an additional 265 taxpayers. In 2009 the three Loveland sites did 855 returns with \$810,000 in refunds. This service is free tax preparation for low income, seniors and disabled people, from Feb. thru April 15.<sup>th</sup>

DAC (DISABILITY ADVISORY BOARD) Diane Hinrichs-handed around copies of email -request for more funding support for the plight of the Disability Resources. The loan closet equipment will most likely be located in the community of Ft. Collins.
