<p>NOTICE OF APPEAL</p>	

1. Plaintiff Shannon M. Lewis, hereafter Appellant, by and through counsel and pursuant to C.A.R. 3, hereby give notice of appeal of the trial court's Order of Summary Judgment, issued June 20, 2016. This notice is timely. C.A.R. 4.

STATEMENT OF THE CASE

2. On October 7, 2015, Shannon Lewis filed a complaint against Defendants for negligence against Defendant Charles C. Richards and respondeant superior against The City of Loveland. Her Complaint against Defendants is grounded in causes of action plead arising from her automobile accident that occurred on December 29, 2014 in Loveland, Colorado. Defendants filed their Answer to Complaint and Jury Demand on December 11, 2015.

3. On March 25, 2016, Defendants filed their Motion for Summary Judgment. In their Motion for Summary Judgment Defendants request a dismissal of Ms. Lewis' Complaint as Defendants believed her causes of action are barred by res judicata, issue preclusion and by collateral estoppel, claim preclusion. Defendants base their argument on the fact that on April 30, 2015 Ms. Lewis' insurer, State Farm Mutual Automobile Insurance Company filed a Complaint against the same Defendants as subrogation action as subrogee of Darren L. Benter and Shannon Lewis. The complaint was filed in the County Court for Larimer County, Colorado and was assigned case number 2015C031448. The action filed by State Farm Mutual Automobile included a claim for relief to recover payments made by State Farm resulting from the December 29, 2014 accident that formed the basis of Ms. Lewis' lawsuit. The action filed by State Farm also included a claim to recover amounts expended by Darren Benter and Shannon Lewis paid to satisfy a deductible associated with their claim. Following an agreement between the parties, the action filed by State Farm was dismissed with prejudice on June 3, 2015.

THE JUDGMENT AND ORDERS APPEALED AND THE BASIS FOR JURISDICTION

4. The Larimer County District Court's June 20, 2016 Order granting Defendant's Motion for Summary Judgment.

5. The Larimer County District Court's Order Granting Defendants' Motion for Summary Judgment prematurely resolved the legal issues between the parties.

FINAL JUDGMENT

6. The judgment is final for purposes of C.R.C.P. 54(b) because it conclusively

resolved all issues between the parties.

THE DATE THE JUDGMENT WAS ENTERED

7. The Larimer County District Court issued its order on June 20, 2016.
