- Staff Deb Callies is leaving the Community Partnership Office to work for the Loveland Housing Authority.
- Commissioner Appreciation event is March 8th at 5:30pm at the Police and Courts building. All commissioners are invited to attend.
- Alison Hade conducted an information session for the City Council on the projects in the Community Partnership Office. Chair Warner and Chair Rice from the Affordable Housing Commission were present.
- HNS dedicated funding from City Council in 2016 (\$70,000 annually) does not have the appropriate documentation to process payments moving forward. This request will need to return to City Council.
- Joint meeting of Human Service Commission and Affordable Housing Commission is Feb. 12th to discuss the Community Housing Development Fund.
- Question by Commissioners about the youth commissioner open positions. Chair Warner will bring this up again with Alison.

Human Service Grant Pre-Applications

- 51 pre-applications were submitted and accepted. 4 pre-applications were submitted but denied due to lack of required information.
- Only 1 housing first application was submitted. The funds for housing first are the CDBG Public Service funds typically awarded to recipients who serve an eligible population.

Human Service Grant Process Review for Commissioners
