Staff Report:

Jeff Bailey reports the Boyd Lake/Mountain Lion project will be moving to the other side as resurfacing will take place this coming Saturday. This project is moving right along. Adds that the Railroad project will begin mid-June barring any further delays. The 8th Street Bridge project is still set to start September 1st and go through April 2019.

Mark Jackson reports that the widening of Highway 34 Bridge will start after the fourth of July. There will be much congestion until that is completed. Highway 402 construction is to begin after that. Mark Jackson offers to bring CDOT in for a detailed presentation on these improvements to the corridor.

Staff is currently scoping the Master Plan updates and taking a whole systems approach. Bike and Pedestrian Plan is tied into Transit. These will take 6-9 months to get full approval. The Transportation Advisory Board will be used as a sounding board for these plans and feedback will be encouraged. Other Boards will also be involved and there will be an increase in public outreach.

Bike to work Month Updates: 13 station locations, with a total of 20. Five stations will host am and pm riders. 35 organization/businesses/departments are hosting this year and 20 are brand new. Activity card of scheduled events is shared with those in attendance. Everyone is encouraged to visit the web site, www.cityofloveland.org/BikeLoveland, for more details.

Mark Jackson asks if there are any other interests Public Works could bring to the Board. Irene asks for more Transit information. Candice states she is currently filling vacancies and improving efficiencies at this time, but will bring more information about route changes, etc. to the next meeting. Irene adds she would like to have an update of the Bike Month activities as well. Additional request to have an update on the Highway 34 PEL.

Dave Martinez:

Asks about the progress on the Transit Center. Candice reports it is with the architect and is in the design phase. The land is secured, but the project is estimated to be two years out. Staff will be applying for grant funding later this year. Dave also reports that the Highway 34/Big Thompson Canyon ribbon cutting was held to celebrate the accomplishments of the project.

Jim Paulmeno:

Appreciated Alex's presentation and notes partnerships are so critical to the success of transit. Mentions the Highway 34 PEL and meeting had 53 attendees, discussed the funding options and timetables of projects.

Irene Fortune:

Irene offers suggestion to bring several Boards together to give additional feedback to the 2045 Regional Transit Element effort. Asks if the Planning Commission would be involved. Jeff states it would and would be an open meeting to discuss that one topic.




Who is the NFRMPO?






