### **Board Member Reports:**

#### **Darin Barrett:**

Visited the new County building and asks if there will be a bus stop there. Candice Folkers reports there will be a stop there and that exact placement is being discussed. There is a stop to the north and another on 1<sup>st</sup> Street now. Darin also asks about the 37<sup>th</sup> Street project. Will there be a bridge? Jeff Bailey reports it will most likely be postponed. The roundabout @ Monroe and 37<sup>th</sup> will be constructed first with the bridge coming at a later time. Funds are a concern. Darin asks the status of the 15<sup>th</sup> Street/Boyd roundabout. Jeff responds the plans have not been approved for that project.

#### **Kimberly Baker:**

Kimberly inquires about the COLT route changes and the passes. Candice explains the times haven't changed so they are still being accepted. Adds that the feedback has been very positive.

#### **Irene Fortune:**

Wants it to be known that Chris Carlson is a talented grant writer. Jeff Bailey agrees. Irene also states she attended the ribbon cutting for the new trail. It runs from Sunset Vista to the south side of Fort Collins. She observes a lot of traffic on this section of trail.

#### **Jim Paulmeno:**

Asks if horses are allowed on this trail? Katie Guthrie responds that they are not permitted on the section that is within the City limits, but other sections may have other regulations.

Katie Guthrie adds that the Northern Colorado Leaders Bicycle Ride is coming up and invites all Board members to participate if they wish.

Mark Jackson reminds everyone the next meeting will be held at the Public Works Administration Building. Topics include a CEF Discussion, an overview of the Initiatives for Innovation and a brief overview of the Transportation Ballot Initiatives. The November meeting will include the Transportation Master Plans, "Connect Loveland", a Pedestrian Gaps analysis and a Shared Active Transportation presentation.

The Transportation Advisory Board endorses the proposed improvements to the COLT bus routes. The board also endorses the proposal to increase the hours of operation of the bus system. The board further wishes to express its appreciation to the City Manager and elected officials that were involved in the hiring of Public Works Director, Mark Jackson and Transit Manager Candice Folkers. In short order, upon occupying their positions they have made positive impacts upon the operation of the Public Works Department.

The board predicts that the proposed improvements to COLT operations will reap benefits for business and for the citizens of Loveland. 

# North Front Range Rail Network




# North Front Range Rail Map Composite

North Section


