Category	
Statement	I create large-scale public sculptures by packing and stacking conic and cylindrical steel forms. Natural geometries and systems, from plant spores; to seashells; to honeycombs; inspire my work where simple rules give rise to extraordinary complexity. My projects are inextricably site specific and dependent and emphasize relational existence of form within contexts of material, process, public space, and collaboration. The parts form a community of similar, yet distinct, dependent elements, which form an aesthetic, structural, and material ecosystem. Analogous to my process, a dry wall mason's objectives and process are constrained and inspired by site, available material, experience, and improvisation, and like my sculpture, are acts of interpretation not declaration. "Concordia" commissioned for the roof of the Downtown Art Center in Lexington, KY demonstrates my approach to site and community. The sculpture rests against two formerly distinct buildings and stylistically

different facades. Just as the Art Center augments, strengthens and shoulders the larger community, my sculpture references the buttress that shores up, reinforces and sustains a larger structure. The rooftop site presented unique challenges, which required extensive consultation with architects, engineers and riggers as well as skillful negotiations with client, city agencies and stakeholders.

Commissioned by the Traverse City Arts Commission in memory of Bryan Crough, a visionary civic and cultural leader, Godfrey's monument "Enspire" echoes the shape of a small chapel or ceremonial hut. One large ring appears as the doorway where visitors may enter the sculpture. Once inside they are completely surrounded by the cellular forms that are heaped up, rising up into gentle dome.

By changing the first letter of the titular word from "i" to "e", this sculpture announces its power to draw people into its center. If "inspire" means to bring about an opening of the imagination and the experience of creative possibility (literally "to be filled with spirit"), then to "enpire" would seem to imply something more physical- to be drawn into a place and to be directed upward.





Artist's Letter of Interest

I would be honored to make a sculpture commemorating the memorials that were washed away for the Viestenz-Smith Mountain Park, Loveland USA. I believe that when the art is harmonious with the site in scale and context it makes for a better viewing experience both now and into the future. I envision a sculpture that at a distance is iconic that would be a landmark that as people get closer they get to see an elaborate composition some of which resolves quickly and other parts get discovered over time.

I believe that art can stimulate and add to the human experience whether it is a grand statement or an intriguing subtle surprise. Of all the media I have explored, steel has offered an exciting range of shapes and surfaces to draw on. Often I use reclaimed and recycled material from scrap yards. The chalkiness of the welder's soapstone pencil I use lends itself to the fluid drawings that are added, subtracted, broken, and blended on the steel forms.

In an effort to capture the organic free associative tapestry of drawings I began hand cutting them out of the rugged yet yielding steel with an oxy-acetylene torch. Recently I started using a plasma cutter which allows me to make sculpture out of stainless steel, bronze and aluminum. The process of rendering the drawings became a natural springboard into sculpture, with all its powerful sensibilities of dimensional touch, scale, light and shadow. The drawings become sculpture and the sculptural forms inspire drawings.

I generally approach making art in a serious and yet playful way. With site-specific Public Art work I am interested in tapping into the locations history and culture. I'm happy to meet with community members. I also research the history of the location including museum archives, reading blogs and you tube videos, which gives me a sense the place and it's people.

Over the last decade I have had the good fortune to be awarded several commission that have engaged me to work with Government committees, Architects, Engineers, Contractors, installation crews and of course Insurance agents. There have been a few challenging moments but I feel blessed that everyone that I've worked with showed up on time got the job done and were great to work with.







Statement Dear Committee Members,

My name is Linda Prokop and I am a professional artist from Loveland. My sculptures are in collections around the country, several of which are on permanent display in our home town. I'm continually exploring imagery that evokes the emotional side of human nature. I feel a strong obligation to communicate the compassionate side of humanity through beauty, grace, and kindness. I return to themes of family and community as they resonate through time and culture, making a universal connection for us all.

I am motivated by the history surrounding the founders of the Viestenz-Smith park. Charles Viestenz was a person of vision and courage embarking on a project where his ideas were considered reckless and wild. Over a considerable amount of time, and with the help of Ray Smith as a consultant, he implemented a reality that served well into the future.

I think this story is as applicable today as it was then. I'm intrigued by the Viestenz-Smith memorial project as an opportunity to depict the importance of our future as a part of the cycle of life. I believe that this theme connects to the vision of the founders, as preserving our future will continue to take ideas that may seem difficult and unobtainable, but are necessary.

In my ongoing creative thought process I have been considering how to communicate ideas that depict how important it is that one thing depends upon another. Our very survival as a species depends on preserving this interconnectedness. Change is an ever present constant and even disasters are a necessary part of that cycle. The flood of 2013 has united our community and achieved a shared resilience as we join together to repair, understand, and move forward. I believe reflecting this commonality in the sculpture memorial to be necessary.







- Below is a summary from our Department Variance Reports through the end of the prior month (11/30/2018).

GENERAL FUND

- Personal Services expenses ended the month 4% under budget.
- Expenses for Supplies ended the month 10% under budget
- Purchased Services ended the month 4% under budget.
- Parks revenue ended the month 2% under budget.
- Recreation revenue is tracking 4% under budget.

GOLF FUND

- Personal Services ended the month 8% under budget.
- Supplies came in 27% under budget.
- Purchased Services came in 8% under budget.
- Golf Revenue ended the month 2% under budget.
- Year-to-date cost recovery is at 123%.



Administrative Processes

- In an effort to offer additional opportunities for professional growth for our staff, at no cost to the City, we have organized a P&R Professional Book Club that has begun meeting once a month (on personal time) to discuss the book chosen for that month. In December, the group has read and discussed “Dare to Lead” by Brené Brown.



- In order to reduce expenses and increase efficiencies, we have condensed from 4 Activity Guides (formerly “Leisure Times”) per year down to 3. This will result in a reduction in printing costs, postage expense, and staff time spent on the guide with no anticipated negative impacts to our users. The department continues to utilize an interactive web-based version of the guide as well, which has helped improve reach and push through to registrations. Our latest issues – our Winter/Spring 2019 guide – went out to the public on December 7th.
- The Department has begun work on the 2020 budget – updating internal budget templates and reviewing capital improvement project budgets. We are also identifying which projects which we will need to submit for re-appropriation funding (roll-overs from '18 to '19).



Parks and Recreation Foundation Business

- YTD in 2018, the Parks and Recreation Foundation scholarship program has **granted 208 scholarships for a total of \$9,674.30** in funds awarded!
- The Foundation raised \$18,786 through fundraising efforts (\$11,453 after fundraising expenses).
- The Foundation has recently reorganized their accounts in order to maximize interest income. We anticipate interest income will grow from approximately \$1,500 in 2018 to more than \$8,400 in 2019 due to these changes.

Planning

- **ADA Transition Plan**

Parks and Recreation staff completed \$100,000 worth of ADA-related improvements in 2018 including trip hazard repairs, the purchase of two accessible golf carts, drinking fountain replacements, signage updates and replacements, and surfacing upgrades to make facilities compliant with ADA regulations. Staff are currently working to develop a work plan for an additional \$300,000 worth of work to occur in 2019 and will provide updates on selected projects as soon as they are available.

- **Playground Replacement**

Per the Department's Depreciation Plan, staff has contracted with Star Playgrounds to design, procure and install new playground equipment at Silver Glen Playground. The existing playground equipment will be removed by Parks and Recreation staff the week of January 14-18, 2019. The new playground will be installed by Star Playgrounds the following week of January 21-25, 2019 and will be open for public use soon thereafter. Notifications of the temporary playground closures will be provided on site and through various social media and email platforms.

The Parks and Recreation Department is also working with J-U-B Engineers to design drainage improvements at Derby Hill Park's playground. The drainage improvements are anticipated to be completed in spring 2019 with replacement of existing playground equipment to occur immediately following drainage improvement completion. An RFP for playground vendors will be issued in early 2019.

Finally, the Department will be issuing additional RFP's in early 2019 for equipment replacement at both Dwayne Webster and Namaqua Parks with installation planned for mid-2019. Specific timelines for installation and opening will be provided as soon as they are available.

- **Copper Ridge Connector**

The department is working with AVI Engineering to develop construction documents for the Copper Ridge Connector, a roughly .5 mile trail connection completing the last recreation trail link between the Long View Trail and future

residential development to the east along the 57th Street Corridor. 60% construction documents are planned for completion in mid-January 2019, at which time Parks and Recreation will commence discussions with BNSF railway regarding a trail crossing of the rail lines at 57th Street. The Department is also working with the developer of the Copper Ridge subdivision east of the rail line to finalize a trail connection through the development to the Copper Ridge Connector.

- **Prairie Ridge Trail**

Parks and Recreation staff are working with J-U-B Engineers to finalize construction documents for the Prairie Ridge Trail, a new trail through the City's Prairie Ridge Natural Area connecting from a new parking area at Wilson Avenue north to the Coyote Ridge Natural Area owned by the City of Fort Collins. The trail design has been carefully planned to work with and respect existing cultural and ecological resources and will mark the beginning of public access to this property. Construction is anticipated in summer of 2019 with a grand opening anticipated in late summer/early fall 2019.

- **Open Lands and Trail Planning and Design**

Planning and Open Lands staff are working together to plan and design various trail connections and segments including a ditch crossing between Madison Avenue and Old St. Louis Natural Area, a ditch crossing and trail connection on city-owned land north of Boedecker Lake, and pedestrian bridge upgrades at Oxbow Natural Area.

In addition, staff are continuing work on a new ADA accessible fishing dock at Willow Bend Natural Area, planning for a connector trail and associated land acquisitions along the Big Thompson River corridor east of Loveland, and assisting with the development of a signage plan and signage improvements along the city's recreation trail system.

Depreciation Funding Projects

- 2018 Asphalt Parking Lot Maintenance – Due to an ongoing maintenance issue at the north parking lot of Mehaffey Park, Goltz Paving completed the paving at the east turn-a-round portion of the lot.
- 2018 Dog Park Maintenance and Resurfacing
Grounds Solutions was contracted to remove and replace the existing pea gravel surface at the Mehaffey Dog Park with a decomposed granite material. This project was completed during the second week of December.
- 2018 Restroom Renovation – Eleven bids were received, and NeuMark was the low bid. Contracts are routing for signature and a project kick-off meeting was held on December 20th. Both the demolition and building permits were sent in. NeuMark would like to start work on January 7th if permits have been finalized.

- 2018 Sports Field Improvements – Centennial Park Ballfields are undergoing some minor improvements.
 - New ballfield screens and fence safety cap is being purchased to replace the weathered and tattered screens and cap at Centennial Park Ballfields.
 - We receiving three bids for the replacement of the dugouts of field #3 inside the ballfield complex. Since the 2013 Flood/recovery, these dugouts are now below the surrounds ground level. The contractor is signing the contract now and should begin work in late December with completion by the end of February.

Misc. or Non-Capital Projects

- Memorial Donation Program – During the month of December, we have accepted a memorial bench donation, which has been placed along the Hogback Trail near Mariana Butte Golf Course. Due to Open lands regulations, this bench will not have a plaque placed on, or near its location.

Capital Funding Projects

- LSP Phase II – Masonry block work for the new mixed use building is scheduled to be completed by the end of the month. Irrigation mainline is 75% complete, and all lateral lines have been installed in the south fields. First lift of asphalt is 100% complete, and final lift of asphalt is 75% complete. Steel work on the shelters has just started.

O & M Activities

- Parks Grounds & Fleet – Winter projects will continue to focus on Ash tree removals, raise tree limbs on spruces to help reduce unwelcome activities taking place under them, and improving the service drive to Owens field at North Lake. Christmas tree recycling will be a priority in January. Fleet will continue to focus on preventive maintenance and refurbishing of equipment used during the growing season such as mowers, trailers and tractors.



Round Mountain CDOT Area Restoration

- A forest fire mitigation project will start January 7th at the Round MT trail head area using funds from a grant obtained by the Big Thompson River Coalition. This work is scheduled to be completed by mid-February and will require the trailhead parking area to be closed. The Round MT-CDOT rock crushing area is currently shutting down and restoration efforts are underway. Final grading and seeding will be completed by mid-January weather permitting
- Cemetery Operations – Sales for December brought in \$20,850 in total, comprised of 4 traditional interments, 4 in ground inurnments and 2 columbarium inurnments. The sale of 3 traditional plots and 4 columbarium niches were also recorded in this total.

- **Sports Turf Section** – Staff continues to maintain winter maintenance routes. Five bids for 2019 Security Services were received and Code 4 Security was low bid. Contracts are routing for signatures. In early December, the Sports Turf section added a new member to the team in Paul Montoya. Paul will be managing a team of part year staff maintaining the ball fields. Annual fertilization of Sports Turf sites and Cemetery properties were completed in early December.
- **Parks Operations** – Staff continues to maintaining winter maintenance routes of year round facilities. Excessive vandalism and unwanted activities at Fairgrounds Park forced the closure of the restrooms for the remainder of the winter season. Additional patrols from security services will continue to help deter these activities. The backstop and dugouts on Owens and North Lake ball fields received a fresh coat of paint as part of small upgrades to these fields. Updating and installing handicap signs throughout the entire parks system is an ongoing project.

Call to Order: The meeting was called to order at 4:30p

Minutes: Minutes from the October 11, 2018 meeting were reviewed and approved without changes.

Council Liaison Report: No update to report as the Council Liaison was not in attendance.

Director's Report: Elizabeth reported that the City is in a hiring freeze and is unable to speak of any new positions opening up at this time. The City is close to being in the black again due to sales tax increase. Elizabeth confirmed the holiday dinner scheduled for December 13th at 6pm and that an invite with more details would be forthcoming in an email from Laurie Gibson. The holiday dinner will take the place of a regular commission meeting as a way to thank the Commission for their service for this past year. Leighton will not be at the holiday dinner due to a prior commitment. Elizabeth discussed the two Commission positions available at the start of the new year as Gene and Leighton are stepping down and did not reapply. Wendi and Councilor Ball will be required to be part of the application and appointment process.

Five-Minute P&R Training Session-Marketing Platform presented by Maria Thomas: Maria shared several new marketing efforts that have taken place over the last year:

- We are using a new promotional request program called Asana, which tracks due dates and deliverables and has made communication of marketing materials more efficient and responsive;
- The Chilson Activity Guide was redesigned earlier in the year and has been condensed from four publications to three per year. This will help reduce expenses related to printing, postage and staff time. We have received positive feedback on the new guide **and** in particular the interactive guide on the website;
- The department's annual report, due out by early February, is getting an overhaul in order to push the design even further. The theme of the annual report is "Creating Connections";
- The "Ask Maria" blog was created to encourage the community to submit questions which Maria then responds to and posts on the P&R website;
- We are using Facebook Live to provide teasers of upcoming events and to drive community engagement;



- Partnerships have been created with local businesses such as AKA Kitchen, I Love Loveland, and Thrive Loveland. I love Loveland has over 20,000 followers on their page and through collaborating with them, we are able to gain even more followers;
- The most significant addition has been monthly eblasts, which also drives more activity registration. John inquired about including survey questions in the eblasts as a way to gather information to present to City Council in hopes of gaining their support for future initiatives regarding P&R.

Review of Recommended Donation Request: Elizabeth shared one donation request submitted by Partners Mentoring Youth. They are requesting few passes from the Chilson Center. Elizabeth approved the request. Wendi asked if the Commission still needs to review these requests since they are already approved. Elizabeth stated that these requests are for their information only unless the Commission wants to be a part of the approval process. Most requests are very minimal in cost and Elizabeth did not think Commission approval was necessary. The Commission agreed they would just review them at this point.

Updated Park Rules and Regulations: Dan provided two copies of the Park Rules and Regulations – both with and without changes. Dan clarified that these are not municipal codes. Changes to these rules and regulations came about suddenly due to continuous reports over the past month of day camping in parks. Because there are no written rules saying people cannot be in tents in the parks during the day, it is impossible for police to enforce. Therefore, it is necessary for the rules and regulations to be updated referencing specific municipal codes so police can enforce through citations. Dan has been working with the legal department to get these changes drafted as quickly as possible and is bringing them to the Commission tonight for review and feedback. Wendi suggested adding the word “shelter” after “privacy” under item #2. Wendi expressed concerns about the timeline of the Commission providing feedback after staff has already met with the City attorneys because, it seems, once the attorneys are involved, things are pretty much final. Wendi does not feel the Commission was given a fair opportunity to brainstorm with P&R and provide feedback before going to the legal department. Dan clarified that anything coming before the Commission at monthly meetings is subject to change at a later time. Due to colder weather and continued issues with camping in parks, Dan was looking for a rapid response to get the changes made as quickly as possible. Elizabeth reiterated that nothing is finalized and changes can be made if requested and to use tonight’s meeting as the time to provide input and make any suggestions. John suggested that size of tents should not be specific to 10’x10’.

Elizabeth also mentioned that a Park Ranger program could be considered to present to Council within the next several years to help enforce rules in parks.

Quarterly Financials: Molly provided a summary of financials beginning on page 22 of the agenda packet and explained that areas in green are revenue and that the furthest right-hand column is the percent of annual. At the end of third quarter, most areas are/should be tracking around 75%. Molly gave a general explanation how each line item is tracking (below, above, or at budget). Molly stated that Recreation budget items are tracking really well, with the exception of Chilson. John

asked why and Molly explained that it is due to competition with private gyms and overcrowding at Chilson. The building supervisor, Ashlee Taylor, is in the process of creating a marketing plan with Maria's help to roll out some new creative marketing options and promotions to increase membership enrollment. P&R is open to new ideas from the Commission. John asked what our department does when Recreation is down \$450,000. Molly explained that, typically, other divisions help compensate for those losses. Molly advised that the second reading on the 2019 budget passed earlier this week, so the budget is final and approved.

Operations and Projects: Wendi asked about the dog park section under Mehaffey and why P&R is taking bids to replace existing pea gravel. Dan explained that there were many complaints that the material is too hot, too large and gets caught between dogs' pads. Elizabeth explained that she and Dan have a meeting next week with Councilor Kathi Wright who takes her dog to Larimer Humane Society and loves their dog park because it has a walking track. Councilor Wright wants to provide her suggestions on expanding the dog park at Fairgrounds Park to include a track similar to the one at the humane society.

Future Topics: Leighton expressed his gratitude to everyone on the Commission and that he has enjoyed being a part of it for the last 12 years. Shane asked why Council is not held to the same standards of attendance as Commission members. Elizabeth explained that attendance is tracked for all Council members and at each Executive Session, not just for the PARC Commission but all Commissions. There is also a council retreat in January to set goals, and the Mayor and City Manager review attendance and responsibilities of Commission members and those items are typically addressed at that time. John expressed his frustration over a variety of things that are being brought up at meetings that he feels should have action by staff or others. He feels that the Commission is not seeing those items coming back around to be able to discuss and put to rest. John pointed to examples of topics that have been mentioned in the past that need further discussion such as metro districts. John says if the Commission doesn't support Metro Districts, then that opposition should be made clear to Council. Another issue that John would like readdressed is spot surveying at Chilson, which was brought up several times in previous meetings by John. He would like to know whether these topics are going to be addressed further. He would like these topics noted along with the person bringing them to the table so the subject can be discussed and concluded. Elizabeth responded that topics brought up at meetings are tracked through notes and minutes. However, how and when items are addressed is based on timing. John asked that further discussion about metro districts occur at the next meeting on how it will affect P&R. Elizabeth will make sure it is on the agenda for January. Molly added that we do keep a running list of topics that is maintained in the office. Again, John suggested that things brought up by any Commission member at any meeting from hereon out be given a 30-second status update in order to give the item closure. It was agreed that any time a Commissioner member has a question
