CITY MANAGER STEVE ADAMS

City Manager Adams presented survey results of the Boards and Commission survey pertaining to PCAB. The overall consensus of the Board was that they are an avid supporter of the police department and they appreciate the updates that Chief Ticer provides them monthly, whether it be crime stats, Police Regional Training Center, body worn cameras and other matters involving LPD. Additionally, the Board appreciates Councilor Overcash's updates pertaining to City Council issues.

City Manager Adams thanked the Board for filling out the survey. Along with the survey information City Manager Adams handed out the information on the Roles and Duties of the Board member as well as the information for each Board member.

City Manager Adams informed the Board that the police department will have a sub-station at The Foundry and should be available for occupancy by the end of April. The hotel should be completed by mid-June and the Metrolux by July 1. The plaza between the theater and apartments has already started to get booked for events.

There are thirty-six (36) cameras that have been placed in the parking garage.

CHIEF TICER

- Chief Ticer reported that Fort Collins had a few minor changes pertaining to the Police Regional Training Center and it is hoped that ground breaking will be in early spring of 2019.
- City Council voted 9 – 0 to approve body worn cameras for all uniformed officers here in the police department. Chief received great comments from Councilor Overcash on Lt. Pyle's presentation for the body worn cameras. Lt. Pyle represented the department very well.
- Lieutenants will be handling PIO duty, each taking a turn on a monthly basis and will submit to the paper on a monthly basis one pro-active report.
- An update on crime stats will be given to the Board on a quarterly basis.
- Chief reminded the Board that the next DDACTS presentation is March 7.
- Members of LPD will be participating in the “Polar Plunge” for Special Olympics on March 9.

COUNCILOR OVERCASH
