ORDINANCE NO. 6280

AN ORDINANCE AMENDING SECTION 2.60.160 OF THE LOVELAND MUNICIPAL CODE DECREASING THE TERM OF LIBRARY BOARD MEMBERS FROM FIVE YEARS TO THREE YEARS

WHEREAS, Section 2.60.160 of the Loveland Municipal Code currently sets forth the membership of the City's Library Board; and

WHEREAS, the Library Board unanimously recommends that the City Council amend Loveland Municipal Code Section 2.60.160 to decrease the Library Board member term from five years down to three years; and

WHEREAS, the three year term is sought after to align the Library Board with other City boards and commissions and the three year term may attract more candidates to serve on the Library Board by a reduction in the term of service; and

WHEREAS, City Council finds that the reduced term, of three years, for Library Board members, is in the best interests of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVELAND, COLORADO:

Section 1. That Subsection A. of Section 2.60.160 of the Loveland Municipal Code is hereby amended to read as follows:


2.60.160 Library Board.

A. There is established a library board consisting of eight members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year; provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other member shall be three years.


Section 2. That as provided in City Charter Section 4-9(a)(7), this Ordinance shall be published by title only by the City Clerk after adoption on second reading unless the Ordinance has been amended since first reading in which case the Ordinance shall be published in full or the amendments shall be published in full.

Section 3. This Ordinance shall be in full force and effect ten days after its final publication, as provided in City Charter Section 4-8(b).


