Minutes The minutes of the 04/24/19 meeting were unanimously approved as submitted.

DISCUSSION/ACTION

The Olde Course at Loveland Clubhouse Feasibility Study

Mark Esoda introduced John Overstreet from Kimley-Horn and Associates, Inc. John Overstreet reviewed the information contained in the preliminary feasibility study distributed to the Board members. Based on current financials and the forecast of future financials, Kimley-Horn recommends renovating the current structure as budget allows.

After a lengthy discussion including, but not limited to, topics of:

- Budget constraints and revenue forecasts
- Opportunities for borrowing funds
- Design build opportunities
- Functionality
- Ability to generate revenues from new area (i.e. winter indoor hitting area)
- Items to be included in a renovation
- Items to be included in new construction
- How budget will be allocated towards project
- Site development/change costs
- Overall estimated costs for either renovating or constructing new areas

- Overall budget number of \$2 million that must cover everything
- Unease of approving options without budget numbers tied to options
- Process towards final design
- Update requested by City Council at the 07/23/19 study session

Jim Whitenight moved that Option A of the Kimley-Horn report (Renovating existing) be approved and that staff be directed to assign estimated costs towards that option. Rex seconded. The motion passed 6 -3.

Budget 2020

Mark Esoda briefly reviewed the information in the packet. The General Fund is being asked to cut 3 – 5% from expenditure budgets. So far Enterprise funds are not be asked to do the same.

Jim Whitenight moved to approve the budget as proposed. Joe Lopo seconded with unanimous approval.
