ORDINANCE NO. 6336

AN ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND SPECIAL IMPROVEMENT DISTRICT NO. 1 BUDGET FOR THE APPROPRIATION OF FUNDS TO MAKE A PREPAYMENT ON SPECIAL IMPROVEMENT DISTRICT NO. 1 REFUNDING BOND SERIES 2015

WHEREAS, the Special Improvement District has reserved funds not anticipated or appropriated at the time of the adoption of the 2019 City of Loveland Special Improvement District No. 1 Budget for the appropriation of funds to make a prepayment on Special Improvement District No. 1 Refunding Bond Series 2015; and

WHEREAS, the City Council desires to authorize the expenditure of these funds by enacting a supplemental budget and appropriation to the 2019 City of Loveland Special Improvement District No. 1 Budget for the appropriation of funds to make a prepayment on Special Improvement District No. 1 Refunding Bond Series 2015, as authorized by Section 11-6(a) of the Loveland City Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVELAND ACTING AS THE EX OFFICIO BOARD OF DIRECTORS OF THE LOVELAND SPECIAL IMPROVEMENT DISTRICT NO. 1 OF THE CITY OF LOVELAND, COLORADO:

Section 1. That reserves in the amount of \$55,000 from unassigned fund balance in the Loveland Special Improvement District (SID) #1 Fund are available for appropriation. Such revenues in the total amount of \$55,000 are hereby appropriated to the 2019 Loveland Special Improvement District No. 1 Budget for the appropriation of funds to make a prepayment on Special Improvement District No. 1 Refunding Bond Series 2015. The spending agencies and funds that shall be spending the monies supplementally budgeted and appropriated are as follows:



Section 3. That this Ordinance shall be in full force and effect upon final adoption, as provided in City Charter Section 11-5(d).
