POLICE CITIZENS' ADVISORY BOARD MINUTES
MONDAY, May 6, 2019

The meeting was called to order by Chairperson **Pat Kistler** at 5:40 p.m. on May 6. **Bev Cardarelli** approved the April minutes. **Chief Ticer** mentioned that **Don Overcash** was not able to make the meeting. Please give him a call if needed.

Chief Ticer

- He asked if everyone is receiving the minutes from the prior meetings in time. They are now being sent through the mail.
- He shared some facts from the annual report:
 - Part 1 crimes reported to the FBI continue to go down with the help of a great staff.
 - Traffic crashes are declining.
 - DUI arrests are going up.
 - Car crashes are going down.
 - Great work by the LPD!
- He shared some facts from the statistical report:
 - Continued reduction in Part 1 crimes.
 - Down 16.6% in Part 1 crimes
 - Arrests are up 15.5% (juvenile crime)
 - 121 DUI arrests
 - Car crashes are down 17%
 - DUI crashes are down 5%

Lt. Pyle

- He mentioned staffing is a little of a struggle but we are continuing to get the job done.
- He shared that they check each week to see where the traffic crashes are happening and where to enforce.
- A problem that we are working on and trying to enforce is people leaving their garage doors open. If we see a garage door open we leave a card.
- We are trying to educate the homeless with our sandwich board signs you see around. On the board it discusses places where they can go for assistance.
- A high priority for this agency is traffic enforcement and crash enforcement.
- We have a good relationship with the traffic department.
- Shoplifting has dropped 17% with using decoy cars
- Our goal is making Loveland safer.

Bev Cardarelli asked Lt. Pyle how the calls works. Lt. Pyle informed everyone that we no longer have Officers positioned with a District. It is up to the Sergeants to determine where the Officers are assigned. Greg Bland stated it is a great proactive strategy. It sounds like it is working wonderfully.

Lt. Pyle discussed DDACTS (Date Driven Approaches to Crime and Traffic Safety). We do DDACTS reviews every 28 days. The different divisions of the PD meet to discuss what has happened during the last 28 days. Chief Ticer asked Sara Wiggett to send out a schedule with all the upcoming DDACTS Review dates. The schedule was sent out either by mail or through e-mail addresses. We look forward to seeing you at the DDACTS Reviews.

Lt. Pyle discussed body worn cameras and where we are in the process. We have received approval from City Council. All the Officers look forward to the cameras. On May 27th the manufacturer will be here to assist in training. The week of May 27th will be full implementation. The community has been supportive. We are super excited to roll them out. Bev Cardarelli asked what activates the camera. Lt. Pyle stated that the camera is activated by the Officer turning it on or when the Officer pulls out his or her taser or gun. Kathy Mitchell asked if the holster will have sensors. Lt. Pyle said yes. All Officers are responsible for wearing them. Ed Gassman said it is great that the Officers are looking forward to wearing them.

Chief Ticer

- He mentioned that the annual statistical report and annual report will be out next month.
- The ground breaking for the Police Training Center will be Wednesday, May 8, at the airport. The ceremony will start at 2:30 p.m.
- In the month of June construction will start. We will be having 11 months of construction.

Detective Danyel McGraw is working with the BATTLE team on identifying stolen vehicles. She works with surrounding areas. We have seen a reduction on auto thefts. The LPR is ran every night and every shift. We are living by our mission statement *Save Lives, Fight Crime, Survive*.

Law Day breakfast is on Tuesday, May 7, at 7:00 a.m. in the Police Institute. We look forward to seeing you.

Robert Cluster discussed the incident that happened to him on June 29. He spoke for two minutes.

Kathy Mitchell made a motion to adjourn the meeting and Bev Cardarelli seconded the motion. The meeting was adjourned at 6:28 p.m.
