ORDINANCE NO. 6342

AN ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR LIBRARY FURNITURE, MATERIALS AND SUPPLIES

WHEREAS, the City has reserved funds not anticipated or appropriated at the time of the adoption of the 2019 City budget for Library Furniture, Materials and Supplies; and

WHEREAS, the City Council desires to authorize the expenditure of these funds by enacting a supplemental budget and appropriation to the 2019 City budget for Library Furniture, Materials and Supplies, as authorized by Section 11-6(a) of the Loveland City Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVELAND, COLORADO:

Section 1. That reserves in the amount of \$27,000 from Library Donations in the General Fund are available for appropriation. Such revenues in the total amount of \$27,000 are hereby appropriated to the 2019 City budget for Library Furniture, Materials and Supplies. The spending agencies and funds that shall be spending the monies supplementally budgeted and appropriated are as follows:






