Fall 2021 Registration Information:

Alumni Registration (for families who had older children attend Small Fries previously but are not currently enrolled)

Tuesday, March 9, 2021; 7:30am – 12:30pm*

Public Registration **Wednesday, March 10, 2021; 7:30am – 12:30pm***

Alumni & Public registration is in-person only at the Chilson Senior Center (using the Senior Center entrance) during the times listed above. Due to COVID-19 restrictions families will receive a number upon arrival. Numbers will begin being distributed at 6:30am. Only a limited number of families are permitted inside the Senior Center at a time. Once full, families will be asked to wait inside their vehicles.

***After 12:30pm on 3/9 & 3/10 and all dates after, registration forms can be dropped off at the check-in table at the Chilson Center main entrance.** All available spaces are filled on a first-come, first-served basis.

Registration Fee:

An annual \$35 per child, non-refundable registration fee is due at the time of enrollment. There is no fee due for wait list enrollments. Tuition fees are set based on the number of scheduled classes in Fall and Spring Sessions. Tuition payment schedules and withdraw procedures are detailed in the Small Fries Parent Handbook and may be paid in full at the start of the session or divided into monthly payments that are due on the 1st of each month within each Fall & Spring session.

Please Note: Children **MUST** turn 3 years old prior to their first day of school in order to enroll in the Th/F Preschool classes. Children enrolling in the M/T/W Pre-Kindergarten classes must turn 4 years old by October 1, 2021. In addition, all children must be toilet-trained prior to their start date in the program.

Small Fries Preschool at the Chilson Center

Program Fees, Tuition Payment Schedules, Withdrawal Procedures, & Refund Request Policies

Please read the following information carefully and initial that you have read and understand it in its entirety on your child's Registration Form. These policies are taken in part from the Small Fries Parent Handbook, which you will be provided with in whole upon your child's enrollment into the program.

Program Fees:

An annual \$35 per child, non-refundable Registration Fee is due at the time your child is enrolled into the Small Fries Preschool program. This fee covers administrative costs of record filing and reporting, and household account management throughout the entirety of the September-May school year for which your child will be enrolled.

Once you have enrolled your child into the Small Fries Preschool program and your Registration Fee has been received, you are committed to making monthly tuition payments as set for the Fall and/or Spring Sessions. **PLEASE NOTE: Enrollment in the Fall Session ensures and guarantees automatic re-enrollment in the Spring Session, granted tuition payments are current, or unless your child is withdrawn from the program.**

Tuition Payment Schedules:

Tuition payments for both the Fall and the Spring Sessions will be calculated based on the number of days that classes are held in each session. Small Fries Preschool generally follows the Thompson School District calendar for major holidays and school breaks. Enrolled families will be notified immediately of these finalized dates & fees. Individual class fees are as follows: \$14/day for Preschool and \$16/day for Pre-K. **If you would like to discuss scholarship opportunities for financial assistance, please call 970-962-2487.**

Withdrawal Procedures:

We depend upon your child's continued enrollment for a successful school year, however we do understand that unexpected events happen in life which may require you to cancel your child's enrollment in the preschool. We encourage you to first discuss any questions or concerns you may have regarding your child's enrollment in the program with the Preschool Director, who will also need to inform the Sr. Recreation Coordinator of your intent to withdrawal your child from the program. At any time, either the parents/guardians of the child enrolled, the Preschool Director, or the Sr. Recreation Coordinator may wish to schedule a conference with all parties in an effort to resolve potential challenges surrounding the reasons for the withdrawal.

In addition, Small Fries Preschool reserves the right to withdraw a child from the program and discontinue services if:

- Parents/guardians refuse to pay full tuition obligations;
- Parents/guardians fail to provide the required medical/immunization records within 30 days of enrollment;
- Extreme behavior challenges exist which cannot be resolved (all efforts will be made to involve parents/guardians prior to withdrawal for this reason); or
- Following all reasonable accommodation requests, program staff feel that the child is unable to function successfully in Small Fries Preschool

Refund Requests:

Should you need to withdraw your child from the program prior to the end of the session for which your child is enrolled, you are subject to the following:

- All withdrawal and refund requests for the Small Fries Preschool program require a 4 week written notice.
- Any tuition payments still due at the time of withdrawal will be prorated to reflect the remaining 4 weeks from the date the written statement is received.
