DUTIES INCLUDE:

- CALL AND NOTICE OF ELECTION
- CERTIFYING ADDRESS BOUNDARIES
- PETITION PREP AND VERIFICATION
- BALLOT PREPARATION ASSISTANCE
- ELECTION PARTICIPATION (IF NEEDED)



COSTS



NOVEMBER 2, 2021 ELECTION

August 3, 2021

Nomination Petitions are Due!

August 24, 2021

Deadline for candidate for file corrected/amended
Nomination Petitions.

August 31, 2021

Deadline for Finance Disclosure Statements
Due 10 days after submittal of Nomination Petitions!



1st day Nomination Petitions could be circulated.

August 23, 2021

Deadline to get signed IGA to the County.

August 27, 2021

Deadline to withdraw from nomination.

September 2, 2021

IMPORTANT DATES CONTINUED

NOVEMBER 2, 2021 ELECTION

September 8, 2021

1st day County Clerk can mail ballots to active electors.
UOCAVA ballots already sent (by September 18).

October 12, 2021

First day Voter Service and Polling Centers open.

November 2, 2021

Last day for counting UOCAVA and other provisional
ballots to be received. (Due on November 10).



Lottery drawing for candidate order on ballot.


October 11, 2021

1st Campaign Finance Report Due.
2nd – October 19; 3rd – October 29 (Friday); 4th - December 2nd.

October 25, 2021

Election!

November 12, 2021



RECOUNT



November 24, 2021

Last day for the County to complete the canvass and submit official abstract of votes cast.



November 30, 2021

Last day an interested party may request a recount.



December 7, 2021

Last day for the County to complete a statutory recount of any race from coordinated election.
