(Application/affidavit must be in contractor's name or master license holders name)
2. Copy of valid identification
3. Application Fee - Valid for 2 years
 - Class A - \$200
 - Class B - \$150
 - Class C - \$125
 - Mechanical, Roofing, other - \$125--No Charge for Electrical & Plumbing contractors--
4. Copy of state license if applicable (Electrical & Plumbing Masters & Contractors)
5. Provide copy of Certificate of Liability Insurance (minimum \$1,000,000 policy, list City of Loveland as certificate holder)
