**Required documents are accepted in PDF format ONLY:**

- 1)** Application completed and signed by the contractor who holds the license.  
**Important: Application must be in contractor's name or master license holder's name.**
- 2)** Include a copy of valid identification:  
Valid Driver's License, State Photo ID, Passport, or other valid government issued photo identification
- 3)** Electrical & Plumbing applicant must provide both a current Colorado master's license and a current Colorado contractor's license.
- 4)** New Licensees must attach: [ICC passed exam](#) OR a valid license from a reciprocal jurisdiction. (Email: [contractorlicensing@cityofloveland.org](mailto:contractorlicensing@cityofloveland.org) for complete list.)
- 5)** Copy of Certificate of Liability Insurance (Minimum \$1,000,000 policy, listing City of Loveland as the certificate holder.)
- 6)** Application Fee - all documents must be received before the application will be processed. Once received staff will be in contact for the payment. Check or credit card is accepted for payment either in person or by phone at 970-962-2638.
  - Class A - \$200 - valid for 2 years
  - Class B - \$150 - valid for 2 years
  - Class C - \$125 - valid for 2 years
  - Mechanical, Roofing, other - \$125 - valid for 2 years
  - Electrical and Plumbing contractors - No Charge - same expiration date as the state license.

*Licenses issued by the City of Loveland which have been expired or inactive for more than 3 years may be renewed upon providing evidence of passing the ICC examination in the appropriate category of licensure under section 15.30.080 of the Loveland Municipal Code.*
