Applicant(s) agrees to investigate, respond to, and provide defense for and defend against any such liability, claims, or demands at the sole expense of Applicant(s) and agrees to bear all other costs and expenses related thereto, including court costs and attorneys' fees, whether or not any such liability, claims, or demands alleged are groundless, false, or fraudulent.
- 2. <u>City Parks and Facilities</u>: Applicant must be invited by the City of Loveland Parks Manager, or a designee, in order to provide mobile vending services at or near City Parks or City owned facilities consistent with Loveland Municipal Code Section 12.30.110(G).
- **3.** <u>Compliance</u>. Applicant agrees to comply with all provisions of the Loveland Municipal Code, specifically Chapter 12.30 of the Loveland Municipal Code, and any applicable City regulations.
