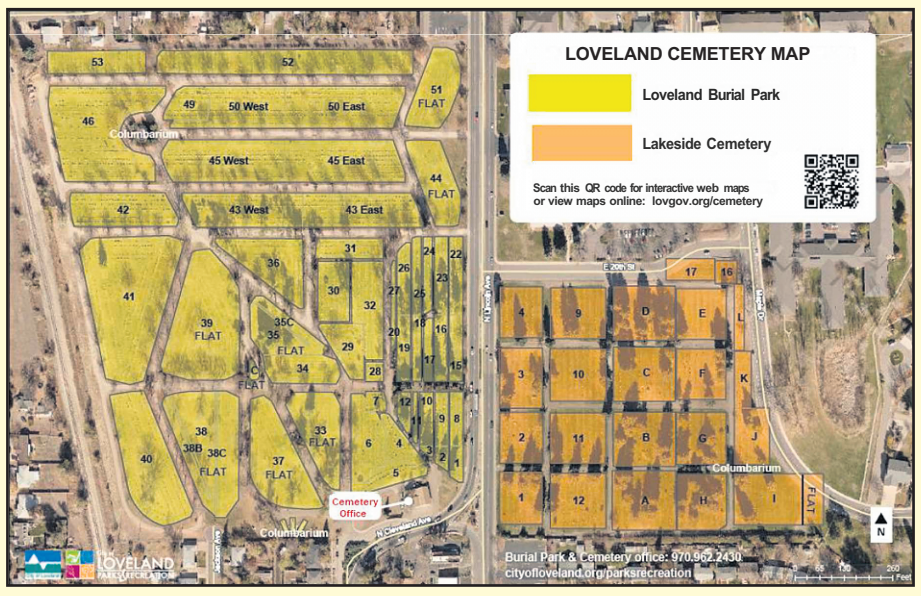


THE CITY OF LOVELAND PROVIDES THIS NOTICE OF INTENT TO TERMINATE THE OWNER’S RIGHTS AND RECLAIM TITLE TO THE LISTED BURIAL SPACES WITHIN LOVELAND BURIAL PARK AND LAKESIDE CEMETERY PURSUANT TO COLORADO REVISED STATUTES 31-25-708. THIS NOTICE ONLY PERTAINS TO BURIAL SPACES PURCHASED BEFORE JANUARY 1, 1947. If you are the Owner, heir or assign, and you wish to retain your right to the burial space, please provide written notice to the City at 500 E. 3 rd Street, Suite 200, Loveland, CO 80537 by June 1, 2023 of your intent to retain ownership of the burial space. Include in your notice of intent to retain ownership the interment certificate number and lot number of the burial space. Additional proof of ownership may be required. After all documentation has been reviewed and verified, a new interment certificate will be issued to you. If the City does not receive a written notice of intent to retain ownership of the burial space, the City will proceed with the reclamation procedure for the burial space.
