### NON-ACTION ITEMS – INFORMATION

**Introduction of Jordan McCormick** Steve Southard introduced Jordan McCormick as the new golf superintendent of the Mariana Butte golf course. Jordan is excited to “compete” in the public sector and to continue establishing a culture of excellence with attention to detail and cleanliness. **2011 Budget Impacts – November Ballot Issues** Skip Armatoski introduced the topic of the ballot measures 60, 61 and 101 and whether the Golf Advisory Board wanted to make an official statement either for or against. The following ideas were discussed; how to educate golfer regarding the ballot issues, ability to post awareness posters at courses, impacts to the courses.

*After a general discussion, Jim Smith motioned that the Loveland Golf Advisory Board officially oppose Amendment 60 and 61, and Proposition 101 by resolution and that the resolution be forwarded to City Council and the Citizen Budget Advisory Committee.*

*Julie Nelson seconded with unanimous approval.*

### **Council Liaison Report**

Councilor Klassen updated the Board on the City Manager selection. The Budget department is working to prepare multiple budget options that reflect different levels of cuts including an option that would address the budget if the November ballot issues, 60, 61, 101, pass.

### **Golf Manager Report**

Steve distributed a mock-up of improvements to #13 green at OCAL. There are quite a few things at OCAL that need to be brought up-to-date. Steve plans to address several small visible projects each spring and a few each Fall. Steve would like to address the playability of OCAL and make in more enjoyable but not necessarily easier.

Several board members offered suggested areas that they felt could use review such as the pin placement on #5 and that all the par 3's on OCAL play exactly the same – every time, always the same club selection; the tees and the hole placements move in conjunction.

Would like to discuss the placement of cart signs on the course and how they may be affecting speed of play.
