Reservations | Deposits

Court and field reservations should be made at least 24 hours in advance of the desired reservation date. Deposits are secured at the time of reservation to ensure proper clean-up, orderly conduct and compliance with park rules and regulations. If a court has not been reserved, it is available for public use on a first-come, first-served basis. P&R programs & reservations take precedence over drop-ins. **By phone M–Th 8A–4:30P, F 8A–3:30P:** 970.962.2432

Cancellations | Refunds

Cancellations must be received at least four (4) business days prior to the reservation date. All cancellations after this deadline will be processed according to the chart below (LSP Championship Field has its own cancellation deadlines). Refunds of the fee and deposit are issued within two (2) weeks of the cancellation date.

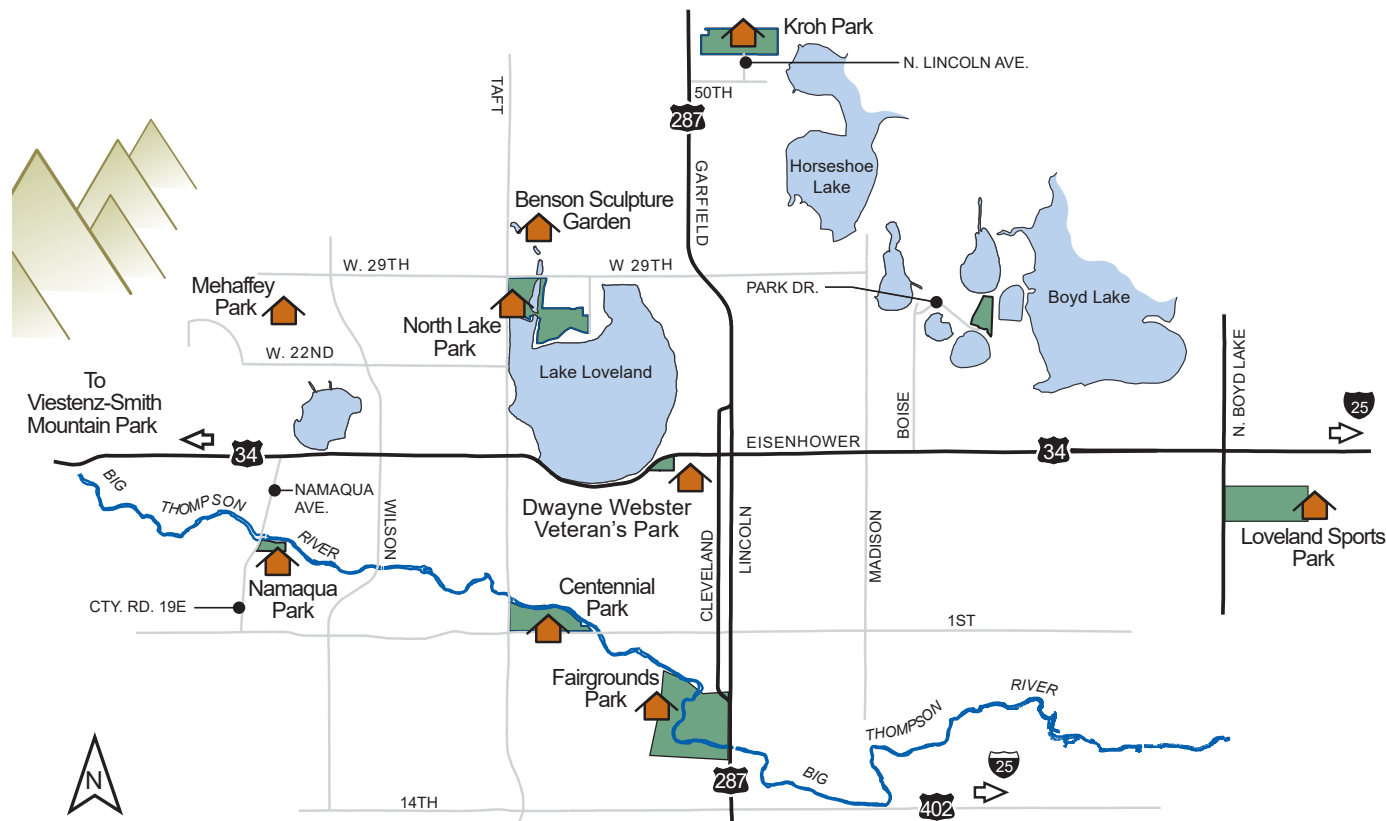

Alcohol Permits

\$75 fee | \$75 deposit
Must be purchased at least five business days prior to the reservation date; permits expire at 10:00P on the day of the reservation.

Electricity

Electricity at shelters | pavilions is available with a paid reservation.

ADA Accessible

All shelters | pavilions are ADA accessible.

Reservations Shelter | Pavilion reservations must be made at least seven (7) days prior to the desired date. Reservations accepted up to nine (9) months in advance of the event date.

All fees and deposits are due at the time of the reservation. Changes to the date or location must be received more than two (2) weeks of the reservation date, otherwise a **\$30 fee** will be assessed. A change to add an alcohol permit to an existing reservation may be made up to one (1) week in advance of the reservation date. **To cancel or change a reservation, please email Parks@CityofLoveland.org or call 970.962.2727.** Groups larger than shelter capacity may require Park Manager approval and are subject to an additional site impact fee. If a shelter has not been reserved, it is available for public use on a first-come, first-served basis.

Deposits Deposits are secured at the time of reservation to ensure proper clean-up, orderly conduct and compliance with park rules and regulations. Please have members of your group observe all posted rules and regulations. Deposits are refunded two (2) weeks after the reservation, provided the shelter is left clean and there are no damages or park policy violations.

Cancellations Cancellations are assessed a **\$50 fee** and must be received at least three (3) weeks prior to the reservation date by the person who made the original reservation. All attempts will be made to reschedule your date. If that is not possible, a refund of the fee and deposit (less the \$50 fee) will be issued within two (2) weeks. If the cancellation is less than three (3) weeks prior to the reservation, the deposit will be withheld, and a refund of the reservation fee will be issued.

Weather: Inclement/severe weather refunds can be made by contacting the Parks & Recreation Administration Office the following business day after a reservation. Please note that cold, wind and rain may not qualify as inclement weather. **Call 970.962.2727 to see if parks staff has determined if the weather situation warrants a refund.**
