## 2025 SCHEDULE

- Pre-Application **due Thursday, March 6<sup>th</sup> before midnight**  
(confirmation email indicates success)
- Grant Proposal **due Thursday, April 10<sup>th</sup> before midnight**  
(confirmation email)
- Presentation email Friday, **April 11<sup>th</sup> before noon**
- Grant presentation: May 8<sup>th</sup> (or May 12<sup>th</sup> depending on # of applications).
- Allocations: May 8<sup>th</sup> (or May 12<sup>th</sup>)
- City Council: June 3<sup>rd</sup>
- Grant year begins October 1<sup>st</sup> with executed contract

## GENERAL INFORMATION

- MUST HAVE: SAMS.gov registration, DUNS number
- Presentation: 20 minutes
- Contracts
- Reports: Due quarterly
- Documents available on the website
  - Grant guide
  - 2025 HUD income guidelines **as soon as available**
  - Quarterly report (this year and next year)
- Grant funds spent by July 31<sup>st</sup> or explanation for extension

## GRANT GUIDE SPECIFICS

- Questions in pre-application copy to application
- MINI CONTRACT. **Please read and ask questions.**
- One proposal for all types of projects (if housing, if public facility, skip if ...)
- Technical assistance available
- Project budget – can use your own or ours
- Minimum you need (Q16) ... how to answer
- Operating budget – rarely used. We will email to you.
- Quarterly reports – one question is 4<sup>th</sup> quarter only

## FEDERAL REGULATIONS

- Davis Bacon. Applies if  $\$ > \$2,000$  or 8 or more units of housing
- Uniform Relocation Act
- Section 3 if  $> \$200,000$
- Lead paint
- Build America, Buy America if  $> \$250,000$

ALL CONSTRUCTION CONTRACTS WILL REQUIRE A PRE-CONTRACT MEETING

- Online grant management system for pre-app and proposal
