Elected officials and members of the Planning Commission must submit an annual Financial Disclosure Statement, or a written notice indicating that there have been no changes to the Disclosure Statement submitted prior to an election (or appointment). Financial Disclosure Statements are also required to be filed within 30 days following their election and annually thereafter before June 1, using forms supplied by the City Clerk's Office.

The City Clerk's Office issues written notification regarding the financial disclosures mandated for the annual filing. Refer to Municipal Code 2.14.010(J). Kindly utilize the attached disclosure form to send your annual filing directly to [clerk@cityofloveland.org](mailto:clerk@cityofloveland.org).

Failure to file the Financial Disclosure Statement in a timely manner may lead to the disqualification of the individual as a candidate for the position being pursued. See City Charter 17-3(c). Please let me know if you have any questions or concerns regarding this information.
