

- (3) Five-Year Consolidated Plan
- (4) Annual Action Plans
- (5) Consolidated Annual Performance and Evaluation Reports

TIMELINE & IMPLEMENTATION



Consolidated Plan: 2025-2029

- Five-year planning document for the use of federal dollars
- Includes needs assessment and market analysis
 - Housing
 - Homelessness
 - Community Development
- Identifies priorities and sets goals




Community Development Block Grant

How Much?	Approx. \$1,900,000 over 5 years \$380,000/year
	65% Brick/Mortar
	15% Public Services
	20% Program Administration

- **Purpose:** Improve the physical, economic, and social conditions for low-income people
- **Eligible Uses:** Principally benefit low- and moderate-income persons, aid in the elimination of slums or blight, and/or meet an urgent community need

Determining Goals





The National Community Survey™ in Loveland

- Survey conducted July 24 – September 4, 2024
- Approach:
 - 4,000 randomly selected households: 612 total responses received
 - 16% overall response rate
 - Open participation: 914 responses
- Results statistically weighted to reflect Loveland overall
- 95% confidence interval with a +/-4% margin of error





- 2) Rehabilitate existing housing
- 3) Improve public facilities
- 4) Enhance access to public services
