

The City of Loveland Local Licensing Authority was called to order at 9:00 AM in the City of Loveland Council Chambers on August 21st, 2025. Honorable Judge Jennifer Edgley presided as the Licensing Authority. City Clerk, Ashley Macdonald, was present along with Sterling Wilson, Assistant City Clerk, Adriana Mazur, and Assistant City Clerk. Sterling Wilson was present as the Secretary to the Authority for this hearing. Michael Bailey, Assistant City Attorney, was present to represent the City of Loveland. Officer Emilie DeLima represented Loveland Police Department as the Marijuana, Liquor, and Tobacco Compliance Officer. The following items were heard and action taken based on the following:

1. CONSENT AGENDA

- A. Minutes from the July 31, 2025, Local Licensing Authority Meeting.
- B. 2025 Local Licensing Authority Rules of Procedure Update.

The Approval of the Minutes from the July 31, 2025 Local Licensing Authority Meeting will be considered on the September 18, 2025 Local Licensing Authority Meeting.

The Authority APPROVED the update to the 2025 Local Licensing Authority Rules of procedure.

2. PUBLIC HEARING

A. Renewal Application – Jensen Restaurant Company dba Justine's Pizza

An application for the renewal of the Hotel and Restaurant License issued to Jensen Restaurant Co Inc., dba Justine's Pizza, was filed on March 3, 2025. The application was filed prior to the 45-day submittal deadline. The licensee has been required to appear regarding the potential transfer of the liquor license and outstanding conditions that were established at the June 13, 2025, Meeting of the Local Licensing Authority. A license transfer application was filed with the Clerk's Office for the Liquor License issued to Jensen Restaurant Co Inc., dba Justine's Pizza by Jackstine's, LLC on August 11, 2025.

In Attendance: Dawit Woldu, Attorney for Jackstine's LLC, Amy Hummel, Purchasing Justine's, Greg Jensen, Owner Jensen Restaurant Co. Inc., Jack Hummel (Amy Hummel's Son), Manager Applicant Jensen Restaurant Co. Inc.

The June 13th Findings were established on the record. The Authority Requested three conditions at the prior hearing:

- 1. The licensee must file a manager registration application for the *de facto manager* of the establishment, Jack Hummel no later than July 7, 2025.
- 2. The Licensee must provide proof of alcohol server training for all new employees hired after Mr. Jensen had delegated responsibility to the *de facto manager*.
- A complete transfer application must be filed OR a clear business plan must be provided establishing how all parties involved are providing proper oversight and abidance to local and state licensing requirements and regulations.

The Applicants provided an explanation as to why they did not initially meet the conditions established by the Authority. There was a misunderstanding of which parties were required to file the manager registration; Jack Hummel filed a COMPLETE Manager Registration Application on August 20, 2025. It was confirmed that new employees HAVE COMPLETED Alcohol Server Training prior to the date of this hearing.

Mr. Jensen provided a statement regarding managing business affairs and explained how the misunderstanding took place. He provided an apology for the confusion surrounding this matter.

Officer DeLima expressed no safety issues with the operation of the business or the training of the employees. Jack Hummel's alcohol server training certificate status had not yet been received by the City. Mr. Hummel established that he would provide evidence of server training certification for the record.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Findings and Action Taken:

The licensee holds the responsibility to monitor and adhere to all filing deadlines during the transfer process. The Authority emphasized the responsibility of the licensee in maintaining community safety, and emphasized that a liquor license is a privilege and not a right: licensees have a legal obligation to comply with all regulations and rules of the Colorado State Liquor Code and Rules and Procedures of the Local Licensing Authority.

Pursuant to Colorado Revised Statutes, 44-3-312(1), as amended, the following findings are present in regard to the application to renew the Hotel & Restaurant **License** issued to the above-mentioned entity, that the applicant **HAS MET** the reasonable requirements of the neighborhood for the type of license for which the application has been made. That the applicant HAS MET the desires of the adult inhabitants, the number, type, and availability of alcohol beverage outlets located in or near the neighborhood under consideration. A COMPLETE application for the renewal of Jensen Restaurant Co. Inc's liquor license was filed with the City Clerk's Office. The manager registration WAS FILED LATE on August 20, 2025. The condition for alcohol server training to be provided for all employees hired after November 2024 IS met. A complete transfer application was filed with the City Clerk's Office, which will be considered at a later date. The public notice and posting requirements **HAVE BEEN MET**. The current licensee **IS** entitled to the premises based on information provided by deed from Mr. Woldu, the Applicants, and Licensee. NO safety concerns have been identified by the Loveland Police Department.

The Authority finds that there are no laws that would preclude the issuance of a temporary transfer permit for the new owners. The City Clerk's Office expressed **NO CONCERNS** preventing administrative approval.

The Authority **GRANTED** the renewal of the Hotel & Restaurant Liquor License currently issued to Jensen Restaurant Company Inc. dba Justine's Pizza and authorized the City Clerk's Office to **ADMINISTRATIVELY APPROVE** a temporary transfer permit to Jackstine's LLC dba Justine's Pizza.

Members of Jackstine's LLC will be required to attend the September 18, 2025 Local Licensing Authority Meeting where their transfer of ownership application for this license will be considered.

B. Show Cause Matter – Loyal Order of the Moose Inc dba Loyal Order of the Moose Lodge 484

A motion has been filed, pursuant to the provisions of § 44-3-901(1)(a), C.R.S. as amended, to the Local Licensing Authority of the City of Loveland to consider suspension or revocation of the Club License issued to Loyal Order of the Moose Inc., dba Loyal Order of the Moose Lodge 484, located at 1408 Morning Drive, in Loveland. Findings and allegations concerning Colorado Liquor Regulation 47-

900 and § 44-3-901(1)(a), C.R.S., serving alcohol to a visibly intoxicated person, are to be considered.

In Attendance: James B. Fairbanks, Attorney, Sheila D. Ehasz, Moose Lodge 484

A summary of the violation was provided for the Authority. Bartender Betty Clark Served a patron 9 (nine) bottles of Bud Light beer between 7:00 PM and 10:50 PM on September 2, 2024. The Patron proceeded to strike a motorcyclist with his truck after leaving the Moose Lodge and driving with a Blood Alcohol Level reported to be over 5 (five) times the legal limit. No victim impact statement was provided at the hearing; however it was established that the victim made a recovery.

A stipulation and entry of no-contest against the allegations of overservice was reached between the City and Mr. Fairbanks, representing his client. The details of this stipulation were summarized:

The penalty that has been agreed upon is a suspension of 21 days, 7 of which will be actively suspended, with the remaining 14 days to be held in abeyance subject to no further violations taking place for a 28-day period after the date of the original violation. The licensee **DOES NOT** hold a recent history of violations or any similar violations identified.

Additional compliance measures were provided by the applicant for the record. Moose Lodge members completed alcohol server training with the Loveland Police Department since the date of the violation. A new point of sale system that tracks alcohol beverage purchases by the drink has been installed. ID scans are required with each purchase. Security cameras have been repositioned for improved monitoring.

Officer DeLima stated the Moose Lodge **HAS BEEN COMPLIANT** and forthcoming when providing records and camera footage and verified the evidence for the record.

Judge Edgley opened the chambers for public comment. No one in the gallery was present regarding this show cause matter and the public hearing was closed.

Findings and Action Taken:

The Authority **ACCEPTED** the stipulation reached between the City and Loyal Order of Moose Lodge 484. The Moose Lodge staff member involved in the incident **REMAINS EMPLOYED** by the establishment. A total suspension of 21 days will be served, beginning on August 25, 2025, and the license will be actively suspended for 7 days. 14 days of this suspension will be held in abeyance for a period of 365 days.

C. Temporary Modification – HP Kitchen Concepts dba Grimm Brothers Taproom

A **COMPLETE** Permit Application and Report of Changes for a Temporary Modification of Premises for a Hotel and Restaurant license was submitted on June 20, 2025, by HP Kitchen Concepts, LLC dba Grimm Brothers Taproom, located at 815 14th St. SW in Loveland. The application was **SUBMITTED PRIOR TO THE 45-DAY FILING DEADLINE**. The modification will consist of an expansion into the restaurant's parking lot to host a car show, vendor, and activity space. The modification will support the 24th Annual Realities Ride & Rally Permission to use the expansion from 7:00 AM to 8:30 PM on August 30th, 2025, was provided by the Landlord, **Warehouse Business Accelerator dba The Forge Campus**. The premise was posted with a sign advertising the Public Hearing on August 1, 2025, and notice of the hearing was published in the Reporter Herald on August 10, 2025.

In Attendance: Brian Allen, (Tyler) Manager, Grimm Brothers Taproom

Mr. Allen described the Realities Ride and his business's role in supporting this charity event. Grimm Brothers Taproom and Kitchen is a family-friendly restaurant. The Realities Ride has been hosted at Grimm Brothers Taproom for two years. Last year's event had no incidents or violations reported to the City Clerk or law enforcement.

Mr. Allen described the expanded alcohol service area and reviewed the submitted Alcohol Control Plan. Security will be provided by Traust Security monitoring entrances and the perimeter in addition to Contracted Loveland Police

Officers (Off-Duty Officer Contracts). The event is expected to host at least 1,500 participants.

Patrons will be required to present ID and will also be issued wristbands to indicate they **ARE** of age to consume adult beverages. Three satellite bars will be featured in the expanded premises in addition to the restaurant's licensed premises and bar. All members of Grimm Brothers Taproom have received TIPS training or similar safe server training, and Realities Ride volunteers have also received alcohol server training as well.

Officer DeLima held **NO CONCERNS** and established that the applicant had addressed her questions in his testimony. The City recommended granting this application.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Findings and Action Taken:

Pursuant to Colorado Revised Statutes, 44-3-312(1), as amended, the applicant is hereby advised that with regard to the application to temporarily modify the premises under their existing **Hotel & Restaurant** License, that the applicant **HAS MET** the reasonable requirements of the neighborhood for the type of license for which the application has been made. The Authority finds that the temporary modification of premises **WAS TIMELY FILED** on June 20, 2025. Exhibit A – The DR 8442 form, Exhibit B – Before Diagram, Exhibit C – After Diagram, and Exhibit D – Site Use Permission letter, and Exhibit E – Alcohol Control Plan comprises the application. The applicant holds a **VALID** City and State Sales Tax License in Good Standing. The granting of this temporary modification permit **WOULD NOT** be injurious to the public welfare and security. Premises control has been deemed **ADEQUATE**. Staff members **HAVE RECEIVED** adequate alcohol service training. Boundaries and barriers **HAVE BEEN** determined to be adequate. Identification policies have been determined to be adequate.

The Authority **APPROVED** the application for a Temporary Modification of Premises for HP Kitchen Concepts LLC dba Grimm Brothers Taproom.

D. Special Event Liquor Permit – Loveland Sertoma Club: The Great Colorado Airshow

A **COMPLETE** application for a Special Event Liquor Permit was submitted on June 12, 2025. The Great Colorado Airshow will take place at Fort Collins Loveland Municipal Airport, 4900 Erhart Rd., in Loveland on September 20, from 9:00 a.m. to 3:30 p.m. and September 21, from 9:00 a.m. to 3:30 p.m. The event will feature aerobatic demonstrations and ground displays. Catered food will be provided and domestic beer, craft beer, hard seltzer, and malt beverage cocktails will be available at the event and served by alcohol-service trained volunteers. Proceeds will benefit the Loveland Sertoma Club, Northern Colorado Regional Airport, The Air Show Network, and various volunteer organizations supported by Loveland Sertoma Club Inc.

In Appearance: Matt Kurtz, Loveland Sertoma Club, Brandon DePerry, The Airshow Network

Loveland Sertoma Club is a service organization that raises funds to support other nonprofits such as the Boys and Girls Club and House of Neighborly Service. This event has been hosted by Loveland Sertoma in 2021 and in years prior. This year's event is expected to host 15,000 attendees per day.

Application details and a description of the event was provided for the record. Security, alcohol service polices, and food served during the event to meet the requirements of a Special Event Liquor Permit.

Food will be supplied by The Airshow Network, consisting of hamburgers, BBQ, and other offerings in addition to snacks.

There will be five points of alcohol service, "food courts," with meals and snacks available. Alcohol will be allowed within the entire general admission area. Two entrance and exit gates will be used. Security will staff each gate. Loveland Police will provide security in addition to contract security. Alcohol served will consist of prepackaged Beer, Seltzer, and "Malt Beverage Cocktails" such as spiked iced tea. Alcohol will be served by The Airshow Network Staff and Sertoma Club Volunteers. 6 (six) Sertoma Club Volunteers will staff each beer tent with at least 1 (one) bartender from the Airshow Network. Sertoma Club

volunteers obtained server training through Loveland Police Department in July of 2025.

Loveland Police Department expects to employ the entire department in some capacity to support the event's security needs. Six private security officers will monitor the event space each day. Six volunteers will also be employed at each gate.

Identification checks will be performed at the point of alcohol service, and all patrons will be issued wristbands to indicate they are of age to consume alcoholic beverages. No limit to drink purchases has been established and patrons will be monitored for overservice.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed. The City recommended approval of this event.

Findings and Action Taken:

The Authority finds that Loveland Sertoma Club MEETS the definition of a nonprofit organization under State and Local Law. The applicant's combined events during the calendar year WILL NOT EXCEED 15 DAYS. The applicant WILL MAKE available sandwiches and light snacks during all hours of service of malt, vinous, or spirituous beverages. The event WILL NOT be injurious to the public welfare in its operation. Security staff and volunteer staff has been deemed to be ADEQUATE to the needs of the event. Identification checks have been deemed ADEQUATE to the needs of the event. The event perimeter as described is ADEQUATE to the needs of the event. All fees and taxes ARE PAID to date.

The Authority **APPROVED** this application for a Special Event Liquor Permit for Loveland Sertoma Club: The Great Colorado Airshow.

E. Renewal Application – Aloha is Colorado LLC dba Da Big Kahuna Bar and Grill

An application for the renewal of the Hotel & Restaurant License issued to Aloha is Colorado LLC, dba Da Big Kahuna Bar and Grill was filed on **April 30**, **2025**, **AFTER the 45-day filing deadline**, **and one day prior to the expiration date**.

The licensee has been required to appear to address an outstanding sales tax delinquency. The matter was continued from June 18, 2025, Local Licensing Authority Meeting. A notice of public hearing **WAS POSTED** on location on August 1, 2025, and a notice **WAS PUBLISHED** in the Reporter Herald on August 10, 2025.

In Attendance: Erynn Helenihi, Owner/Manager

Ms. Helenihi stated for the record that after consideration, she decided to close her business and cease operations. The Clerk's Office will provide a surrender affidavit for her State and Local licenses.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Findings and Action Taken:

The City Clerk's Office provided for the record, a Clerk will coordinate the surrender process with the licensee immediately following the hearing.

F. New Hotel & Restaurant License – Belly Buster LLC dba Belly Buster Sushi

A complete application was filed on June 30, 2025, for a new Hotel & Restaurant License by Belly Buster LLC, dba Belly Buster Sushi, located at 6055 Sky Pond Dr. in Loveland. The application was filed PRIOR TO THE 45-DAY FILING DEADLINE. The neighborhood boundaries were designated as: NORTH – Crossroads Blvd.; SOUTH – HWY 34.; EAST – Highland Meadows Pkwy.; and WEST – Aldrin Dr. The premise WAS POSTED with a sign advertising the Public Hearing on August 1, 2025, and a notice WAS PUBLISHED in the Reporter Herald on August 10, 2025.

In Attendance: YingYing Zhao, Owner/Manager, Erin McCollough, Oedipus Petitioning.

Sarah Winter, Loveland Fire Rescue Authority Inspector, and Kent Fierstine, City of Loveland Sales Tax Manager provided additional testimony.

Prior to the date of the hearing the applicant had been delinquent on sales tax payments. The applicant is currently **COMPLIANT** with City Sales Tax.

Ms. Zhao described her business: it is a sushi restaurant that opened earlier in 2025 and patrons have requested alcohol with their meals.

Erin McCollough with Oedipus Petitioning provided results of the Neighborhood Needs and Desires Petition. The petition was circulated on August 6 and August 7, 2025. Only inhabitants of the neighborhood were considered and required to verify their age, 21 years or older. 100% of participants of the petition indicated they were in favor. 107 signatures were collected for the petition from the defined boundary from businesses and residences.

The Applicant **HAS NOT COMPLIED** with Fire Code to this date. The Kitchen Hood System and fire suppression system were identified as noncompliant. The applicant currently **DOES NOT** comply with the Fire Code. The applicant is working to address these issues as stated. Additionally, the load occupancy limit was addressed on the record as noncompliant and the Applicant provided a statement that she would remedy the amount of seating in her restaurant to comply.

Officer DeLima expressed **CONCERNS** regarding the restaurant staff's training. It would be helpful for her staff to receive proper training to ensure that they fully understand liquor law.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Mr. Bailey recommended that this item be continued to another LLA Hearing due to the outstanding issues with Fire Code and Alcohol Server Training.

Findings and Action Taken:

The Authority moved the matter for the September 18, 2025 Local Licensing Authority Meeting to allow the applicant to address outstanding issues with the Loveland Fire Authority's Fire Code and obtain Alcohol Server Training.

G. New Beer & Wine License – Tingus Restaurant Group Inc. dba Slice House by Tony Gemignani

A complete application was filed on July 8, 2025, for a new **Beer & Wine License** by Tingus Restaurant Group Inc., dba Slice House by Tony Gemignani, located at 1385 Sculptor Dr. in Loveland. The application was **FILED PRIOR TO THE 45-DAY FILING DEADLINE**. The neighborhood boundaries were designated as: **NORTH – Park Dr.; SOUTH – W 1st Street.; EAST – N Boise Ave.; and WEST – McWhinney Blvd.** The premise **WAS POSTED** with a sign advertising the Public Hearing on August 1, 2025, and a notice **WAS PUBLISHED** in the Reporter Herald on August 10, 2025.

In Attendance: Mike Tingus, President/Part-Owner, Tingus Restaurant Group, Jaime Tingus, Part-Owner, Shawn Agresto, Registered Manager, Erin McCollough, Oedipus Petitioning.

The Neighborhood Needs and Desires Petition was circulated by Oedipus Petitioning on August 5, 8, 9, 2025 between residential and business addresses within the designated boundary map. Only inhabitants of the neighborhood were considered and required to verify their age, 21 years or older. The results of the petition were verified as follows: 99% of participants were in favor, with 112 total signatures collected. 2 signatures opposed the application.

A brief description of the restaurant chain and its history was provided: The restaurant will serve pizza, pasta, and appetizers comprising a full menu. Alcohol holds a low priority and compliments the food menu. Hours will be from 11 AM to 10 PM.

The proposed licensed premises were described: A service counter will be available to dispense beer and wine, however the restaurant will not offer bar service. An enclosed patio will also be included which can be monitored from the service counter.

The restaurant is still under construction, with a Certificate of Occupancy expected on September 2nd. The applicants have been compliant with permitting and have a final building inspection scheduled for September 5th. The restaurant has planned for a grand opening on September 27th.

The Applicants' experience in the alcohol service industry was discussed. Mr. and Mrs. Tingus **DOES NOT** have prior experience in the alcohol beverage

industry. Shawn Agresto, the registered manager, **HOLDS** 20 years of experience in the alcohol beverage and hospitality industry.

A record was made regarding the alcohol storage locations in the restaurant. Beer and wine will be stored behind the service counter. Beer will be stocked primarily in the tap system itself and will be held mostly in the serving area, with a limited back-stock. Alcohol will only be stored in the red-lined area on the submitted diagrams, which does not include the restaurant's kitchen.

Beer and wine will be sold by the glass or bottle. Applicant's staff have received alcohol server training, with Shawn Agresto completing a course through Alcohol Beverage Training. The applicants expressed interest in coordinating a private class with Officer DeLima for their employees.

Identification will be checked with each alcohol sale. A calendar kit for quick birth-date reference called a "We-ID Kit" will be used by staff to quickly reference birthdates on a calendar. Staff members will review practices for spotting fake IDs and server training policies will be employed. Only one drink will be sold per person at each sale; customers may not purchase multiple servings. Vertical IDs will not be accepted. Patrons will be monitored for signs of overservice. Staff will receive training on how to spot patrons who are already intoxicated and will also cover policies for spotting signs of marijuana consumption.

Officer DeLima must inspect the premises, however, cannot do so until the location's construction work is completed.

The City recommended that approval should be contingent on the issuance of a certificate of occupancy and completion of all necessary inspections.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Findings and Action Taken:

The application was filed **TIMELY** on July 8, 2025 for a new Beer and Wine License. Prior to the application, there has been no denial of a liquor license in the same location for at least two years. The premises **IS NOT** located within 500 ft of a public school, college, university, or seminary. The applicant **HAS MET** the reasonable requirements of the neighborhood for the type of license for which the

application has been made. That the applicant **HAS MET** the desires of the adult inhabitants, the number, type, and availability of alcohol beverage outlets located in or near the neighborhood under consideration. The application has been submitted **COMPLETE**, however if the applicants wish to amend their application to alter the alcohol storage areas as discussed during the meeting, **A NEW DIAGRAM MUST BE FILED PRIOR TO APPROVAL OR UPON MODIFICATION.**

The Authority will **CONDITIONALLY APPROVE** this application for a new Beer and Wine License for Tingus Restaurant Group Inc. dba Slice House by Tony Gemignani. The conditions of approval consist of the following:

- 1. An updated diagram for alcohol storage must be submitted.
- 2. Completion of all necessary inspections and issuance of a certificate of occupancy
- 3. Completion of alcohol server training by all employed staff members

H. Temporary Modification – Ovations Food Services LP dba Spectra Hot Dog Cart: Good Guys Car Show 2025

A complete Permit Application and Report of Changes for a Temporary Modification of Premises was submitted on July 8, 2025, by Ovations Food Services, LP dba Spectra Hot Dog Cart, located at 5290 Arena Circle in Loveland. The application was **SUBMITTED PRIOR TO THE 45-DAY FILING DEADLINE**. The modification will consist of an expansion of alcohol service into the parking lot at Blue Arena between Building 2 and 7. Permission to utilize the expansion was granted by **The Ranch Events Complex** from September 5, 2025, to September 7, 2025, to host the 2025 Good Guys Car Show. The premises **WERE POSTED** with a sign advertising the public hearing on August 1, 2025, and a notice **WAS PUBLISHED** in the Reporter Herald on August 10, 2025.

In Appearance: Emily Meister, General Manager OVG Hospitality

The Applicant provided a description of the modification including physical barriers, security, and food service requirements for the record. The event will host roughly 15,000 attendees daily. The expanded area will comprise of exhibition space and demonstrations. The entrance and exit to the area were

established as follows: Gate 1 on the Blue Arena/Fairgrounds campus only. This area will be monitored at all times by Best Security.

Any sale of alcohol will require a valid ID to be presented. Wristbands will not be issued. 6 (six) bartenders will staff the event with 2 (two) operating each bar location, 3 (three) bars total. All bartenders are ServSafe Certified for alcohol service. Blue Arena Security will be present in addition to at least 2 (two) Larimer County Sheriff's Deputies that regularly staff Blue Arena.

Food Trucks will provide full meals and light snacks. No more than two beverages will be sold per person, and the limit will be strictly enforced.

Officer DeLima had NO CONCERNS regarding premises control or safety.

Judge Edgley opened the chambers to receive public comment. No one was present in favor or opposition to this item, and the public hearing was closed.

Findings and Action Taken:

The Authority finds that the temporary modification of premises **WAS TIMELY FILED** on July 8, 2025. The DR 8442, Exhibit A – Before Diagram, Exhibit B – After Diagram, Exhibit C – Alcohol Control Plan, and Exhibit D – Site Use Permission letter comprises the application. The applicant holds a **VALID** City and State Sales Tax License in Good Standing. The granting of this temporary modification permit **WOULD NOT** be injurious to the public welfare and security. Premises control has been deemed **ADEQUATE**. The car show is the primary purpose of the event. Food and vendors where alcohol will be a compliment to the exhibits and demonstrations. Staff members **HAVE RECEIVED** adequate alcohol service training. Boundaries and barriers **HAVE BEEN** determined to be adequate. Identification policies have been determined to be adequate.
