Meeting Called to Order: 6:00 pm

Approval of the Minutes: Larry moved to accept the minutes; John T. seconded the motion. Motion approved.

Treasurer Report: John S. said that no interest was received in December, but over the year the account made 29 cents. The current balance is \$711.29.

#### LIAISON REPORTS

DRS: Dave reported that DRS is getting remodeled and making room. The Fort Collins office bought a building and will be a more permanent part of the community; the building will be better and more accessible. Dave relayed that a mentally ill homeless man called him and stated that some Loveland police officers were harassing him. Dave called the Police Department and inquired about its policy on homelessness. Dave learned that some officers may be harassing the homeless, but there is no policy. Discussion ensued regarding the issue and that some people may deserve to be "run out of town."

Staff: Bettie said that the City's Boards and Commissions Summit is planned for March 1, and the City is requesting two volunteers from DAC. In addition, DAC needs to submit a list of accomplishments for 2011. Discussion ensued regarding the following accomplishments: Barrier Awareness Events, Plan Reviews, Budweiser Events Center Accessibility, Participation in an ADA Appeal with City of Loveland Transit, and DAC's 35<sup>th</sup> Anniversary Commemoration. Bettie will submit these accomplishments for DAC. John T. and Zach agreed to attend the Summit.

Bettie also mentioned that DAC needs to draft goals for 2012 and update subcommittee assignments. Members agreed that this subject should be on DAC's February's agenda.
